ADDITIONAL COMMENTS: While Iowa is only meeting two of the five performance indicators, it should be noted that extensive technical assistance and training has been provided to local areas in regard to Credential Attainment and Measurable Skills Gain. State staff identified impacted records and worked with local areas and other State Agencies to collect information and make necessary updates. Further training and technical assistance will continue for program year PY24 focusing on case management and service delivery instead of just collecting enrollments, to further increase performance outcomes for these measures. While enrollments were down for Adult and Dislocated Workers for PY23, the Youth program saw an increase by 11.7% from PY22 to PY23. To continue the efforts to improve outcomes, Iowa's focus for PY24 will be on ongoing training on data integrity, the accurate recording of performance outcomes, career planning, outreach, and follow-up.
