ADDITIONAL COMMENTS:

Both State of Oregon and federal funds are expended to cover the full cost of employment services provided to Oregon businesses and citizens. The composition of state and federal funds used varies based on the allowable funds available, timing of financial decisions, and approval of contract reimbursements. Per the agency's federally approved cost allocation plan, staff charge their time to an intermediate cost pool, and costs are allocated based on job seeker services recorded in our data system. Dedicated program specific staff directly charge their specific programs. The final calculations and fiscal business decisions occur after time sheets have closed for the month.

In program-year 2023, the Oregon Employment Department expended the following on Wagner-Peyser eligible services.
