All Users Must Now Use PIRL 2021.

For all reports submitted for the report quarter ending 9/30/2022 or later, the only option for submitting is PIRL 2021.

New DWG Upload Process

A new upload feature for Dislocated Worker Grants (DWG) allows for a state to upload a PIRL file on behalf of a Local Workforce Board (LWB) or other entity as a separate upload. Certain DWG grantees have partnered with State Workforce Agencies (SWA) to complete the required participant reporting in WIPS. These grantees have agreements in place with SWAs that meet the requirements under 20 CFR 603.10.
