ENDED - WIPS Support for PIRL 2018 and PIRL 2020.

Starting with the quarter ending September 30, 2022 grantees can no longer submit a file using the 2018 or 2020 versions of the PIRL, and all files for quarters ending September 30, 2022 and later must use the 2021 version of the PIRL. For states submitting WIOA Annual Performance Reports, the PY 2021 Annual Report will be the last annual report where the 2018 or 2020 versions of the PIRL will be available.

New DWG Upload Process

A new upload feature for Dislocated Worker Grants (DWG) allows for a state to upload a PIRL file on behalf of a Local Workforce Board (LWB) or other entity as a separate upload. Certain DWG grantees have partnered with State Workforce Agencies (SWA) to complete the required participant reporting in WIPS. These grantees have agreements in place with SWAs that meet the requirements under 20 CFR 603.10.

Each file will generate associated QPRs which will then need to be certified. In these cases, the DWG grant number is no longer attached to the state's list or profile, the DWG grant number is associated with the state user's individual profile.
