> WIB Code Management

- Program user can approve or reject edited ETA Codes for only assigned Region.
- The existing ETA Codes with status "Approved" can be edited and submitted for ETA Code approval for changes.
- Regional program user can either approve the changes which would reflect under WIB Code OR reject the changes.
- Edited WIB Codes which are rejected revert to original status and information.
- Edited WIB Codes which are approved reflect approved changes.
- Email notification to state user for approved existing WIB Codes.
- Email notification to state user for rejected changes for existing WIB Codes.
