- Restricted the list of Programs to only display program with certified reports for the selected Quarter End Date and applicable to states or grant numbers

❖ **Data Export** enhancements

- Updated existing functions
 - Quarter End Date now must be selected before all other filters are enabled
 - Program(s) filter changed to Target Program(s)
 - Header Option default changed to Element Numbers
 - Removed Gzip File Format option since all exported files will now be in Gzip format
 - Resulting Schema updated to change Chosen Program to Selected Target Program
- Added new Filters
 - Funding Stream(s) allow more granular selection of data and one or more may be selected from the list below
 - Note that the Resulting Schema will be Full PIRL if at least one Funding Stream is selected

- Users can enter a portion or all of a Grant Number (without dashes), but the number must match the list of grant numbers in WIPS for the selected Target Program
- Additional Filters currently has the following options

 - Training (PIRL 1300) = 1
 - Homelessness (PIRL 800) = 1

- Additional Filter Options have the following choices for any Additional Filters selected
 - Match All (default)
 - Match One or More
- Updated and added new columns to the Completed Export Requests list

 - Funding Stream(s)
 - Additional Filters

 - Region
 - State
 - Grant Number
 - Removed Gzip Format
- Updated the metadata added to each row in the exported file
 - File ID
 - Row number (only populated for PIRL 2018 data)
 - Quarter End Date
 - Target Program(s) list
 - State or Grant number
- Enhanced the retrieval of previous data export requests
 - Previously requested data export results are now available for up to one year
 - Retrieve will fetch the data for you, email is sent when retrieval is complete and Download is available after email is sent
