> OPR

- User will not see "Retrieve" hyperlink for Drilldown file which was generated before this implementation if those drilldown measure were generated using file uploaded by other user.

• Minor changes to Credential Rate for the Total Current Period for WIOA Youth.

> APR

- The Drill Down Measure Request feature for QPR is only available if grantee uploaded the file. User might had access to Drill Down feature but access is disabled for security reasons.

> H1B QPR

- The new H1B QPR has 3 time periods
 - Quarterly
 - Rolling 4 quarters
 - Grant to Date
- The new H1B QPR has Numerator and Denominator for the performance Indicators. The new "SHOW NUMNERATOR/DENOMINATOR" button is added for Section C: Primary Indicator of Performance on the report. Clicking this button shows numerator and denominator values used to calculate the measure.
- When the numerator and denominator values are show, status of the button changes to "HIDE NUMNERATOR/DENOMINATOR".
- The numerator and denominator are shown for Primary Indicator of Performance:
 - Employment Rate (Q2)
 - Employment Rate (Q4)
 - Median Earnings
 - Credential Rate
 - Measurable Skill Gains
- The Numerator/Denominator values are not available for print view.
