In the 20 States with the highest estimated year-round MSFW activity, as identified in guidance issued by the Secretary, there must be full-time, year-round outreach staff to conduct outreach duties. For the remainder of the States, there must be year-round part-time outreach staff, and during periods of the highest MSFW activity, there must be full-time outreach staff. All outreach staff must be multilingual, if warranted by the characteristics of the MSFW population in the State, and must spend a majority of their time in the field.

¹ Significant MSFW States are those States designated annually by the Department of Labor (the Department) and must include the 20 States with the highest number of MSFW participants. [20 CFR 651.10](#).

Participant means a reportable individual who has received services other than the services described in [20 CFR 677.150\(a\)\(3\)](#), after satisfying all applicable programmatic requirements for the provision of services, such as eligibility determination. [20 CFR 651.10](#).

Due to the COVID-19 pandemic, State Workforce Agencies (SWA) documented irregular MSFW participant levels, which were not consistent with historical MSFW activity. Therefore, the Department took participant levels in PY 2019 as well as PY 2020 into consideration.

Significant MSFW State designations in this document will remain applicable until the Department issues a subsequent determination.

II. Significant MSFW One-Stop Centers and Significant Multilingual MSFW One-Stop Centers ²

The following One-Stop Centers are designated as Significant MSFW One-Stop Centers and Significant Multilingual MSFW One-Stop Centers for PY 2021, as indicated.^{3 4}

- Employment Service (ES) offices where MSFWs account for 10 percent or more of annual participants in employment services, or
- ES offices which the administrator determined must be included due to special circumstances, such as an estimated large number of MSFWs in the service area.
- Due to irregular One-Stop Center MSFW data in PY 2020, Significant MSFW One-Stop Center designations for PY 2021 retained all One-Stop Centers from PY 2020, unless a SWA provided information to support that a given One-Stop Center should be removed. The PY 2021 designations include additional One-Stop Centers for which SWAs provided information to support that they should be designated as Significant One-Stop Centers.

Significant Multilingual MSFW One-Stop centers are those designated annually by the Department and include those Significant MSFW ES offices where 10 percent or more of MSFW participants are estimated to require service provisions in a language(s) other than English, unless the administrator determines other One-Stop Centers also must be included due to special circumstances.
