- 4. <u>Details.</u> Attachment VI to TEGL 19-18 contained minor errors. The corrected Attachment VI explains that housing grantees must report individuals and their family members under both categories simultaneously, if applicable, to measure the impact of housing on individuals and households, consistent with the definition of "family" at 20 CFR 685.110 and the indicators of performance for grantees providing NFJP housing services at 20 CFR 685.400. For example, if a grantee provides permanent housing services to a family of 8, the grantee must report that it provided these services to one family and to 8 individuals. The corrections are reflected in the "Definitions" table that begins on p. VI-2. Specifically, the "Note:" that is included at the end of each definition has been updated, beginning with the row of that table that provides the definition for "Total New Migrant and Seasonal

Farmworkers (MSFW) (will receive permanent housing services each quarter)" and in each subsequent row of the table. All other information in TEGL 19-18 remains the same.
