1. **<u>Purpose</u>**. To announce the release and availability of ETA Occasional Paper 2009-22: *Think Entrepreneurs: A Call to Action – Integrating Entrepreneurship into the Public Workforce System Throughout America.* 

2. <u>Background</u>. In July 2008, the Employment and Training Administration (ETA) awarded the Consortium for Entrepreneurship Education a grant for a period of one year to analyze current entrepreneurship operations and policies in the public workforce system, and collect information on ways Workforce Investment Boards and One-Stop Career Centers currently provide support for developing entrepreneurs. Utilizing this information, the Consortium developed an online clearinghouse and a report to broadly share best practices on entrepreneurship activities within the public workforce system.

3. <u>Publication Description</u>. This publication was designed to encourage the workforce investment system to make entrepreneurial/self-employment training opportunities available for people interested in self-employment under Title I of the Workforce Investment Act of 1998. This document includes recommendations for dissemination opportunities for clarifying DOL/ETA entrepreneurship policies, examples of what the field is doing in the area of entrepreneurship, and provides descriptions of how to implement entrepreneurship training strategies.
