1. <u>Purpose</u>. To announce the release and availability of a NAWS national summary report on hired crop workers and associated public-use data files.

2. <u>Action Requested</u>. This notice is for informational purposes.

3. Summary and Background.

- a. Summary This report and associated data files provide information on demographic and employment characteristics of hired crop workers in the United States.
- b. Background The Department of Labor (DOL) has administered the NAWS since 1988. The survey collects employment, demographic, and health information on agricultural workers in the United States. The report summarizes findings from Fiscal Years 2015 and 2016. Federal agencies and public and private service programs use the data for planning, implementing, and evaluating farm worker programs.

The primary data file, which replaces the 1989-2014 file, contains 358 variables and 66,553 observations from interviews that the contractor conducted in Federal fiscal years 1989-2016.

The remaining files contain variables from questionnaires DOL fielded on behalf of the National Institute for Occupational Safety and Health (NIOSH) and the Environmental Protection Agency (EPA) in federal fiscal years 2009-2010 and 2013-2014, respectively.

Specifically, the NAWS NIOSH file contains 37 variables and 3,691 observations from a questionnaire that gathered information on mental health, and the NAWS EPA file contains 37 variables and 4,325 observations from a questionnaire that gathered information on length of the workday and hygiene and clothes laundering practices.
