SUBJECT: 2021 Unemployment Insurance (UI) State Information Data Exchange System

(SIDES) Seminar

1. Purpose. To provide information regarding the virtual 2021 UI SIDES Seminar to be hosted by the National Association of State Workforce Agencies (NASWA) on May 26 - 27, 2021.

2. Action Requested. State Administrators are encouraged to share this information with appropriate staff and support staff participation in the UI SIDES Seminar.

3. Summary and Background.

- a. Summary This notice announces the annual UI SIDES Seminar that will be conducted virtually by NASWA in 2021.
- b. Background NASWA, a national organization of state administrators of the publicly funded state workforce system, operates SIDES on behalf of the states. SIDES is a web-based system that allows electronic transmission of UI claims information between UI agencies and employers. In past years, NASWA has offered an annual inperson UI SIDES Seminar for states. For 2021, the UI SIDES Seminar will be hosted virtually and scheduled from 1:00 pm ET to 5:00 pm ET on May 26 and 27, 2021. The purpose of the seminar is to provide information on SIDES usage, operational issues, and to facilitate SIDES-related business and technical discussions between state UI agencies and employers or their third-party administrators (TPAs).

The UI SIDES Seminar will highlight promising state practices with a focus on improving UI integrity and implementation of SIDES exchanges. Some of the workshop topics include: exploring UI improper payments and root causes; implementation of various SIDES exchanges; state strategies for increasing employer participation in SIDES; incorporating SIDES into UI information technology modernization projects; and preparing for the transition to the new SIDES separation information exchange standard format.
