

## Allowable Training Types by Program

This chart provides a list of what types of training can be reported for each program. Note that these trainings must meet all other program requirements specified under such program's applicable rules to be provided. A 'Y' in the table indicates that some training funded by that program may have that training type reported in *Type of Training Service #1* (PIRL 1303), *Type of Training Service #2* (PIRL 1310), or *Type of Training Service #3* (PIRL 1315). Note that a participant who is co-enrolled in multiple programs may have services provided under one program that are not permitted to be funded under other programs.
