## **Program-Specific Differences and Notations**

<u>Provision</u> of training in each program must meet their own requirements as described in each program's separate guidance. This section provides clarifications on <u>reporting</u> where an individual program deviates from the broader reporting rules. See Attachment I for a chart of which training types may be funded by each program.

## A. WIOA Adult

No notable deviations from the instructions in the main body of this guidance.

# **B. WIOA Dislocated Worker**

No notable deviations from the instructions in the main body of this guidance.

# C. WIOA Youth

- a. On the Job Training (OJT) is considered a work experience for the WIOA Youth program and is not reported as a training in the PIRL. Instead, report OJT as a work experience in *Most Recent Date Received Internship or Work Experience Opportunities* (PIRL 1203) and *Type of Work Experience* (PIRL 1205).
- b. Entrepreneurial Training is a program service for the WIOA Youth program and is not reported as a training in the PIRL. Instead, report this service in *Most Recent Date Youth Received Entrepreneurial Skills Training* (PIRL 1413).
- c. For the WIOA Youth, YouthBuild, REO Youth, and Jobs Corp programs, Occupational Skills Training should always be reported as Youth Occupational Skills Training (10) rather than Occupational Skills Training (06) in *Type of Training Service #1* (PIRL 1303), *Type of Training Service #2* (PIRL 1310), or *Type of Training Service #3* (PIRL 1315), as applicable.

# **D.** Dislocated Worker Grants

No notable deviations from the instructions in the main body of this guidance.

### E. H-1B Skills Training Grants

a. The H1B does not report ABE or ESL services as an additional training in the PIRL.

# F. Indian and Native American Programs Adult

No notable deviations from the instructions in the main body of this guidance.

# G. Indian and Native American Programs Youth

No notable deviations from the instructions in the main body of this guidance.

## H. Trade Adjustment Assistance (TAA)

- a. The definition of enrollment for the purposes of reporting does not affect the enrollment rules for Trade Readjustment Allowances (TRA) under the TAA Program.
- b. TAA considers the provision of ABE or ESL services not in conjunction with training to be training. TAA is the only program that allows for ABE or ESL not in conjunction with training (07) in *Type of Training Service #1* (PIRL 1303), *Type of Training Service #2* (PIRL 1310), or *Type of Training Service #3* (PIRL 1315), as applicable.
- c. Apprenticeship trainings provided under 20 CFR 618.635(c) that are not registered under the National Apprenticeship Act should be reported as On the Job Training (01) in *Type of Training Service #1* (PIRL 1303), *Type of Training Service #2* (PIRL 1310), or *Type of Training Service #3* (PIRL 1315), as applicable.

## I. YouthBuild

a. For the WIOA Youth, YouthBuild, REO Youth, and Jobs Corp programs, Occupational Skills Training should always be reported as Youth Occupational Skills Training (10) rather than Occupational Skills Training (06) in *Type of Training Service #1* (PIRL 1303), *Type of Training Service #2* (PIRL 1310), or *Type of Training Service #3* (PIRL 1315), as applicable.

### J. Registered Apprenticeship

- a. For Type of Training Service #1 (PIRL 1303), Type of Training Service #2 (PIRL 1310), and Type of Training Service #3 (PIRL 1315): If OJT or Skill Upgrading is being provided to an individual as part of a Registered Apprenticeship program, the code value Registered Apprenticeship (09) must be used. This emphasizes both the importance of apprenticeship and the fact that OJT and Skill Upgrading may be components of an apprenticeship program.
- b. If a pre-apprenticeship is provided and includes a training component, it should be reported as a separate training with the applicable training type (typically Occupational Skills Training (06)) for *Type of Training Service #1* (PIRL 1303), *Type of Training Service #2* (PIRL 1310), or *Type of Training Service #3* (PIRL 1315), as applicable.

# K. Reentry Employment Opportunities Adult

No notable deviations from the instructions in the main body of this guidance.

### L. Reentry Employment Opportunities Youth

a. For the WIOA Youth, YouthBuild, and REO Youth program, Occupational Skills Training should always be reported as Youth Occupational Skills Training (10) rather than Occupational Skills Training (06) in *Type of Training Service #1*  (PIRL 1303), *Type of Training Service #2* (PIRL 1310), or *Type of Training Service #3* (PIRL 1315), as applicable.

#### M. Job Corps

a. For the WIOA Youth, YouthBuild, REO Youth program, and Job Corps, Occupational Skills Training should always be reported as Youth Occupational Skills Training (10) rather than Occupational Skills Training (06) in *Type of Training Service #1* (PIRL 1303), *Type of Training Service #2* (PIRL 1310), or *Type of Training Service #3* (PIRL 1315), as applicable.

#### N. National Farmworker Jobs Program (NFJP)

a. Adult Basic Education (ABE) or English as a Second Language (ESL) Not in Conjunction with Training: NFJP Basic Skills Training includes, but is not limited to, English language acquisition such as English for non-English speakers and integrated education and training programs (non-OJT) such as remedial reading, writing, communication, mathematics. NFJP's Basic Skills Training is not considered a training for the purposes of reporting in *Type of Training Service* #1(WIOA) (PIRL 1303), *Type of Training Service* #2 (WIOA) (PIRL 1310), or *Type of Training Service* #3 (WIOA) (PIRL 1315). However, the total actual hours for these services should be reported under *Basic Skills Training funded by* 167 grant (PIRL 2221), as applicable.

#### **O.** Strengthening Community College Training Grants (SCC)

No notable deviations from the instructions in the main body of this guidance.
