SUBJECT: Notification of a New Multi-factor Authentication (MFA) Requirement for State

Users of the U.S. Department of Treasury's (Treasury) Automated Standard

Application for Payments (ASAP) System

1. <u>Purpose</u>. To notify State Workforce Agencies (SWA) of a new access requirement impacting recipient organization users of Treasury's ASAP system.

2. Action Requested. The U.S. Department of Labor's (DOL) Employment and Training Administration (ETA) requests that SWAs provide information contained in this Training and Employment Notice (TEN) to appropriate staff. State ASAP.gov application users must enroll and register MFA credentials as outlined in this TEN by no later than September 15, 2023.

3. Summary and Background.

- a. Summary Treasury is implementing enhanced login security for the ASAP system and will be requiring users to login using MFA in September of 2023. ASAP users must enroll and register MFA credentials with either Login.gov or ID.me no later than September 15, 2023. Any user who has not enrolled and registered through one of the two MFA websites by the deadline will be unable to access the ASAP.gov application.
- b. Background Treasury's ASAP system is used daily by SWAs to draw both State and Federal Funding from Unemployment Trust Fund (UTF) accounts managed by Treasury's Bureau of the Fiscal Service. To prevent public users from logging into ASAP.gov, Treasury will require all recipient organization users to access the ASAP system using MFA beginning in September 2023. Treasury's Fiscal Service has requested ETA's assistance to ensure that state ASAP users are aware of this new requirement and the upcoming deadline for users to comply. Failure to comply with this new requirement may result in a state's inability to access the ASAP.gov application to draw funding needed to pay unemployment compensation benefits.

4. Resources and Information for State ASAP Users

Treasury will require all users to enroll and register for MFA credentials through Login.gov or ID.me no later than September 15, 2023, to continue accessing the ASAP.gov application. Treasury's Bureau of Fiscal Service has provided a number of resources for recipient organizations to ensure all users are prepared for this new mandate and are able to maintain uninterrupted access to the ASAP.gov application.
