Apprenticeship Building America Grant Program

AGENCY: Employment and Training Administration, Department of Labor

ACTION: Amendment to FOA-ETA-22-06

SUMMARY: The Employment and Training Administration announced on February 23, 2022, the availability of funds and the Funding Opportunity Announcement (FOA) for the Apprenticeship Building America Grant Program to be awarded through a competitive process. This amendment revises language in the FOA.

The document is hereby amended as follows:

SECTION III. ELIGIBILITY INFORMATION

Section III.A.1 State Apprenticeship System Building and Modernization:

Amended Text (new language in bold):

Required Partners: For states with federally-recognized SAAs, the SAA must be included as a partner (if not identified as the grant recipient). Federally recognized SAAs are defined as those SAAs that have formal, written notice from the OA Administrator affirming the state's regulatory compliance with 29 CFR Parts 29 and 30. Each state is limited to one individual application for consideration under this opportunity.

States with federally-recognized SAAs that do not yet have formal, written notice from the OA Administrator affirming the state's regulatory compliance with 29 CFR Parts 29 and 30 must provide as part of their application a description of their activities towards obtaining regulatory compliance with 29 CFR Parts 29 and 30. This description must clearly identify steps taken to seek formal approval for 29 CFR Parts 29 and 30, including: submission of request for approval to OA, communications with OA, preliminary approval letters, steps taken to make modifications based on OA recommendations, or other efforts the state can document for consideration. This document must be uploaded as an attachment to the application package and labeled "Efforts in obtaining compliance with 29 CFR Parts 29 and 30."

Section IV.B.1.a Requirement for DUNS Number
