**Enhanced Transitional Jobs Demonstration (ETJD)**

**AGENCY:** Employment and Training Administration (ETA), Labor

**ACTION:** Notice: Amendment to SGA/DFA PY 10-11

**SUMMARY:** The Employment and Training Administration published a notice in the Federal Register on March 3, 2011, announcing the availability of funds and Solicitation for Grant Applications (SGA) for the Enhanced Transitional Jobs Demonstration (ETJD) to be awarded through a competitive process. This amendment to the SGA changes language in Section I.A. and Section III.D.1. The document is hereby amended.

**Section I.A. 2<sup>nd</sup> Bullet, the following text should be replaced with the new text:**

Old Text – Ex-Offenders. Ex-offenders are adult offenders, ages 18 and older who have been convicted as an adult under Federal or State law, and who have never been convicted of a sex-related offense, and who have been released from a Federal or State prison within the past 120 days.

New Text – Ex-Offenders. Ex-offenders are adult offenders, ages 18 and older who have been convicted as an adult under Federal or State law, and who have never been convicted of a sex-related offense, and who have been released from a Federal or State prison or county penal institution within the past 120 days. Those convicted of sexual crimes, either as the presenting offense or a previous offense, are not eligible to participate in the ETJ Demonstration.

**Section III.D.1. The following text should be replaced with the new text:**

Old Text - Ex-Offenders. Ex-offenders are adult offenders, ages 18 and older who have been convicted as an adult under Federal or State law, and who have never been convicted of a sex-related offense, and who have been released from a Federal or State prison within the past 120 days. Those convicted of sexual crimes, either as the presenting offense or a previous offense, are not eligible to participate in the ETJ Demonstration.

New Text - Ex-Offenders. Ex-offenders are adult offenders, ages 18 and older who have been convicted as an adult under Federal or State law, and who have never been convicted of a sex-related offense, and who have been released from a Federal or State prison or county penal institution within the past 120 days. Those convicted of sexual crimes, either as the presenting offense or a previous offense, are not eligible to participate in the ETJ Demonstration.
