For any application that is not a party to the Kansas v. DOL litigation, as explained in OFLC's September 10, 2024, announcement, field descriptions will refer to "v2" as the form version, while any application that IS a party to the Kansas v. DOL litigation will refer to "v3" as the form version.*

Please note: Agricultural businesses are required to complete H-2A Addendum B – Additional Place of Employment Information when the employer needs the workers to perform the services or labor required in the agricultural clearance order at additional places of employment other than the place disclosed in Section C, Items 1 through 5. Within the H-2A Addendum B – Additional Place of Employment Public Disclosure Data, there may be multiple listed housing information per application. Records will be displayed in a variable length record format.
