

# ENHANCED TRANSITIONAL JOBS DEMONSTRATION PROJECT

**GRANTEE:** City and County of San Francisco

**PROJECT TITLE:** Transitions SF

**TARGET POPULATION:** Non-Custodial Parents

**LOCATION OF GRANT ACTIVITIES:** San Francisco, California

**KEY PARTNERSHIPS:** San Francisco Human Services Agency (HSA), the San Francisco Department of Child Support Services (DCSS), the San Francisco Sheriff's Department (SFSD), and Goodwill Industries of San Francisco, Marin and San Mateo, Walden House and Family Services Agency (FSA) of San Francisco, One Family and Parenting Inside-Out programs for ex-offenders and incarcerated individuals, and at least fifteen employers including, Book Pig; A Topnotch Security Services, Inc.; Siteler Wash; McKenzie Warehouse; Cahill Contractors; State Farm; Weitzen Agency; San Francisco Soup Co.; San Francisco MUNI transit; Departments of Public Works and Parks and Recreation, the San Francisco Human Services Agency; Red Cross; La Raza Legal Central; Lilly Brown Community Center; and Goodwill.

**KEY FEATURES:** The City and County of San Francisco's Office of Economic and Workforce Development (OEWD), which staffs the San Francisco Workforce Investment Board, will lead the Transitions SF program in collaboration with the HSA, DCSS, SFSD, and Goodwill Industries to provide participants with intensive case management and barrier mitigation at a unique adult education charter school, and a three-tier system of transitional jobs with nonprofit, public, and private sector employers. Other services such as legal aid, basic, soft, and technical skills training, and behavioral health care will also be provided. Transitions SF is targeting non-custodial parents ages 18-59, with minor children, who reside in San Francisco and who have been identified by DCSS as either delinquent in child support payments or non-job ready. Transitions SF will provide services to those that are ex-offenders as well. Through this demonstration project, Transitions SF plans to build on the City's highly successful Community Jobs Program (CJP)/Jobs Now employment programs, and a number of innovative practices at DCSS, the OEWD, SFSD, and HSA.
