Dear Judge Berlin:

On behalf of Google Inc., we are writing to respond to the Court's inquiry regarding Google's availability to appear on a teleconference regarding pending motions on February 16, 2017. Unfortunately, Lisa Sween, Google's lead litigation counsel in this matter, took ill yesterday, and is hospitalized at this time following emergency surgery. Ms. Sween had been preparing for the anticipated teleconference, and plans to and will appear on Google's behalf at future hearings on the pending motions. Though Ms. Sween is expected to make a full recovery, Google respectfully requests that the Court reschedule the teleconference. Google suggests Friday, February 24, 2017 after 2 p.m. as a potential time for the teleconference, subject to the Court and opposing counsel's availability.

Our understanding is that the teleconference may include discussion of substantive issues relating to this case, the schedule of deadlines, and rulings by the Court. For good cause shown due to Ms. Sween's illness, Google also respectfully requests that the Court

permit Google to file its Opposition to OFCCP's pending Motion for Summary Judgment three days after the teleconference, whenever the conference is ultimately scheduled.
