PARTIES' JOINT CASE MANAGEMENT STATEMENT

Over the course of the past week, since Plaintiff Office of the Federal Contract Compliance Programs, United States Department of Labor ("OFCCP") and Defendant Oracle America, Inc. ("Oracle") submitted their Joint Case Management Statement, OFCCP and Oracle have each communicated with mediator Eric Green multiple times about continuing the parties' efforts to resolve this matter through mediation; these communications also have included substantive settlement negotiations. As of yesterday afternoon, it appeared that OFCCP and Oracle were close to agreeing to continue the mediation process, but the parties are awaiting further information from Professor Green, who is engaged in another matter today and has been unavailable all day. OFCCP and Oracle expect to finalize an agreement about continuing the mediation next week, including dates for the additional mediation, and respectfully and jointly ask the Court to continue the stay while the agreement and arrangements are finalized. If agreeable to the Court, OFCCP and Oracle will file a further Joint Case Management Statement as soon as they can finalize the agreement, but no later than next Friday, May 11, 2018, reporting on whether they believe the stay should remain in effect. If not, the Joint Case Management
