PARTIES' JOINT CASE MANAGEMENT STATEMENT

Pursuant to the Order dated February 27, 2018, and the Joint Case Management Statement submitted by the parties on May 4, 2018, Plaintiff Office of the Federal Contract Compliance Programs, United States Department of Labor ("OFCCP") and Defendant Oracle America, Inc. ("Oracle") hereby file this Joint Case Management Statement. The parties continue to be involved in active efforts to resolve this matter through the mediation process with mediator Eric Green, and have scheduled their next mediation session to take place on July 20, 2018, which was the earliest mutual date of availability for Professor Green and the parties. In between now and July 20, the parties anticipate their ongoing discussions will continue, and also have agreed, with the assistance of Professor Green, to engage in a meaningful exchange of data and information to both facilitate the mediation process and ensure that if the case does not resolve, progress has been made towards better preparing the case for hearing.

In order to allow the parties to continue their efforts to resolve the case through the mediation process, the parties respectfully and jointly ask the Court to continue the stay until Monday, August 13, 2018. If agreeable to the court, the parties also propose submitting a further

Joint Case Management Statement on Friday, August 10, 2018, reporting on the status of mediation. If mediation efforts have not resulted in a resolution and the parties believe further mediation efforts would not be productive, the Joint Case Management Statement will include proposed interim pre-hearing deadlines, as well as a new proposed hearing date.
