**JOINT REQUEST FOR SCHEDULING CONFERENCE**

Following Plaintiffs' Notice of Unavailability of Expert Witness, filed on September 9, 2019, OFCCP has additional information regarding OFCCP's expert's availability. Counsel for OFCCP and Oracle have met and conferred about the grounds for modifying the scheduling orders in the case, and the parties agree that the availability of OFCCP's expert impacts the schedule for this case. The parties agreed to take the dates for the depositions of the experts off calendar and to reschedule them for later dates. However, the parties have not reached agreement on a proposal to the Court for modifying other dates in the scheduling orders.

Due to the impending deadlines in this case, including the September 13, 2019 deadline for expert discovery and the September 25, 2019 deadlines for *Daubert* motions and dispositive motions, the parties respectfully request a telephonic case management conference to be held this week, at the Court's convenience, so OFCCP can provide the Court with further details about its expert's medical condition (in a more confidential forum than a public filing), and so both parties can obtain the Court's input regarding modification of the case schedule, and particularly the

upcoming deadlines.
