On June 19, 2019 Plaintiff Office of Federal Contract Compliance Programs (“OFCCP”) filed a Motion to Compel Oracle’s Compensation Analyses. Exhibit 3 of that Motion consisted of Oracle’s Affirmative Action Plan and related analyses.

On July 2, 2019 Defendant Oracle America, Inc. (“Oracle”) filed Oracle America, Inc.’s Motion to Seal Portions of Plaintiff’s Motion to Compel Oracle’s Compensation Analyses (“Motion to Seal”). In support of that Motion to Seal, Oracle filed the Declaration of Victoria Thrasher.

Exhibit A to Ms. Thrasher’s declaration consisted of Exhibit 3 of OFCCP’s Motion as that exhibit was served on Oracle by the OFCCP. That document was missing every other page.
