Dear Shauna,

I am again following up with the status of the requested items dated 08/28/2015 and previous follow up on 09/21/2015. I have yet to receive a status update from you. Please provide status and expected date to submit the data to OFCCP.

Additionally, I want to bring it to your attention regarding the Labor Condition Applications (LCAs) that your client, Christian Herrmann from Fragomen, Del Rey, Bensen & Loewy, LLP, had submitted to OFCCP so far. The OFCCP had received up to batch #5 for HQCA, which was received by OFCCP on 08/26/2015. So far, OFCCP received a total 413 LCAs for 832 employees.

An original status update was sent to Mr. Herrmann on 09/02/2015 regarding 1) the number of remaining LCAs to be submitted for Redwood Shores, CA and 2) the date that OFCCP expect to receive all remaining LCAs. Mr. Herrmann noted on the same day that he is looking into the matter and will notify me shortly with an update. Mr. Herrmann and I left each other voice messages on 09/15/2015 to return each other's voice message. A follow-up request was sent to Mr. Herrmann on 09/29/2015 as I have yet to hear back from him.

The OFCCP wish to expedite the audit but unable to do so as we are still waiting for multiple outstanding items to be submitted to OFCCP. I appreciate you and your staff for continuing to compile the data for OFCCP. We would like Oracle to provide a firm date as to when OFCCP expect to receive the requested items dated 08/28/2015, remaining LCAs expected to be submitted to OFCCP, and multiple outstanding items from previous correspondences between Oracle and the OFCCP.
