[REDACTED] has the desired high skilled technical knowledge and understanding to test these services for security risks using security tools, proxy, fuzzers and other open source testing tools, performing network scans and analyzing network traffic, testing [REDACTED], writing automation script, creating custom fuzzing scripts, cryptographic protocols testing, source code reviews via [REDACTED] running automation scans, checking for OWASP Top 10 vulnerabilities, and testing application and services as per Oracle [REDACTED] guidelines. [REDACTED] recently involved in testing security of [REDACTED] implementation of compute infrastructure and found a critical issue that infrastructure network is not properly protected. He implemented automation for this testing via Cloud Watchdog and keeps working on overall process to secure it. He also performed manual security penetration testing for [REDACTED], [REDACTED], [REDACTED] and [REDACTED] and caught over 60 security issues before the service goes to production.
