PARTIES' JOINT CASE MANAGEMENT STATEMENT

Following the Order dated May 11, 2018, Plaintiff Office of the Federal Contract Compliance Programs, United States Department of Labor ("OFCCP") and Defendant Oracle America, Inc. ("Oracle") hereby file this Joint Case Management Statement. Despite multiple mediation sessions with Professor Eric Green, the parties were unable to fully resolve the case.

OFCCP has filed a motion with Chief ALJ Jennifer Gee seeking to have the case reassigned in light of Oracle's timely raised objection to these proceedings, consistent with *Lucia v. SEC*, No. 17-130 (S. Ct.) (June 21, 2018). Accordingly, the Parties respectfully request that the Court stay all proceedings pending the outcome of that motion. In the event the case is reassigned, Oracle reserves its right to challenge whether the ALJ assigned to the case is lawfully appointed and whether it is legally permissible for that ALJ to preside over this matter. OFCCP does not agree that there is any basis to challenge the authority of a newly-assigned ALJ to preside over this matter.


