PLAINTIFF'S NOTICE OF ERRATA

On January 22, 2019, Plaintiff filed a Motion for Leave to Amend the Complaint, accompanied by the Second Amended Complaint as Exhibit A.

Plaintiff has discovered two typos in the Second Amended Complaint. On page 2 of Exhibit A, beginning in the carry-over paragraph from page 1, the Second Amended Complaint should read (corrections in bold):

Oracle underpaid women in jobs in its Product Development, Information Technology and Support Job Functions, resulting in pay disparities as high as 20%. This disparity affected **women on** more than 5,000 **occasions** over the period of this lawsuit.

For Asian employees, the story is very similar; Asians were underpaid (relative to White employees) in jobs in Oracle's Product Development Job Function, resulting in pay disparities as high as 8%. This disparity affected **Asians on** more than 11,000 **occasions** over the period of this lawsuit.


