

2019 Small Business Goaling Program

The Office of Small and Disadvantaged Business Utilization (OSDBU), under the Office of the Assistant Secretary for Administration and Management, directly supports the Department's compliance with the requirements of Section 15(K) of the Small Business Act (15 U.S.C. 644(k)) as enacted by Section 221 of Public law 95-507; which recognizes the establishment of prime contracting small business goals for federal agencies.

The OSDBU administers the Department of Labor's responsibility to ensure procurement opportunities for small businesses, small disadvantaged businesses, women-owned small businesses, HUBZone small businesses, and small businesses owned by service-disabled veterans. The Department of Labor's component agencies have individual small business goals that are established with the OSDBU. The OSDBU employs the practice of working with component agencies to set annual goals that will cumulatively meet or exceed the goals set for the Department by the Small Business Administration (SBA). The component agency small business goals are based on the historical small business performance, agency mission and Departmental small business goals established with the SBA.
