Conciliation Agreement Between the U.S. Department of Labor Office of Federal Contract Compliance Programs And Industria Inc. OFCCP Case No. R00306475

I. Preliminary Statement

The Office of Federal Contract Compliance Programs (OFCCP) evaluated the Industria Inc. (Industria) establishment located at 2860 S. River Road, Suite 100, Des Plaines, IL 60018, beginning on April 15, 2022. OFCCP found that Industria failed to comply with Executive Order 11246, as amended (E.O. 11246 or the Executive Order), and the respective implementing regulations at 41 C.F.R. Chapter 60.

OFCCP notified Industria of the specific violations and the corrective actions required in a Notice of Violation (NOV) issued on December 14, 2022. In the interest of resolving the violations without engaging in further legal proceedings and in exchange for sufficient consideration described in this document, OFCCP and Industria enter into this Conciliation Agreement (Agreement) and its attachments, and the parties agree to all the terms therein.

II. General Terms and Conditions

- In exchange for Industria's fulfillment of all its obligations in this Agreement, OFCCP will not institute administrative or judicial enforcement proceedings under E.O. 11246, based on the violations alleged in the NOV. However, OFCCP retains the right to initiate legal proceedings to enforce this Agreement if Industria violates any provision of this Agreement, as set forth in Paragraph 10, below. Nothing in this Agreement precludes OFCCP from initiating enforcement proceedings based on future compliance evaluations or complaint investigations.
- 2. OFCCP may review Industria's compliance with this Agreement. As part of this review, OFCCP may require written reports, inspect the premises, interview witnesses, and examine and copy documents. Industria will permit access to its premises during normal business hours for these purposes and will provide OFCCP with all hard copy or electronic reports and documents OFCCP requests, including those specified in this Agreement.
- 3. Nothing in this Agreement relieves Industria of its obligation to fully comply with the requirements of E.O. 11246, Section 503, VEVRAA, their implementing regulations, or other applicable laws requiring nondiscrimination or equal employment opportunity through affirmative action.
- 4. Industria agrees that it will not retaliate against any potential or actual beneficiary of this Agreement or against any person who files a complaint, who has provided information or assistance, or who participates in any manner in any proceeding in this matter.

- 5. The parties understand the terms of this Agreement and enter into it voluntarily.
- 6. This Agreement constitutes the entire Agreement and represents the complete and final understanding of the parties. This Agreement contains all of the terms binding the parties and it supersedes all prior written and oral negotiations and agreements. Any modifications or amendments to this Agreement must be agreed upon in writing and signed by all parties. If an administrative error is found, OFCCP will work in good faith with all parties to make the corrections.
- 7. This Agreement becomes effective on the day it is signed by the District Director (Effective Date).
- 8. If one or more provisions of this Agreement is deemed unlawful or unenforceable, the remaining provisions will remain in full force and effect.
- 9. This Agreement will expire sixty (60) days after Industria submits its final progress report required in Section IV, below, unless OFCCP notifies Industria in writing before the expiration date that Industria has failed to fulfill all of its obligations under the Agreement. In this instance, the Agreement is automatically extended until the date that OFCCP determines that Industria has met all of its obligations under the Agreement.

10. If Industria violates this Agreement:

- a. The procedures at 41 C.F.R. 60-1.34 will govern:
 - i. OFCCP will send Industria a written notice stating the alleged violations and summarizing any supporting evidence.
 - ii. The Industria shall have fifteen (15) days from receipt of the notice to respond, except in those cases in which such a delay would result in irreparable injury to the employment rights of affected employees or applicants.
 - iii. If Industria is unable to demonstrate that it has not violated the Agreement, or if OFCCP alleges irreparable injury, enforcement proceedings may be initiated immediately without issuing a show cause notice or proceeding through any other requirement.
 - iv. In the event of a breach of this Agreement by Industria, OFCCP may elect to proceed to a hearing on the entire case and seek full make-whole relief, and not be limited to the terms in the Agreement.
- b. Industria may be subject to the sanctions set forth in Section 209 of the Executive Order, 41 C.F.R. 60-1.27, and/or other appropriate relief for violating this Agreement.

- 11. Industria does not admit any violation of the Executive Order, Section 503 or VEVRAA, nor has there been an adjudication on the merits regarding any such violation.
- 12. OFCCP may seek enforcement of this Agreement itself and is not required to present proof of any underlying violations resolved by this Agreement.
- 13. The parties understand and agree that nothing in this Agreement is binding on other governmental departments or agencies other than the United States Department of Labor.
- 14. Each party shall bear its own fees and expenses with respect to this matter.
- 15. This Agreement is limited to the facts of this case. Neither this Agreement, nor any part of the negotiations that occurred in connection with this Agreement, shall constitute admissible evidence with respect to any OFCCP policy, practice or position in any lawsuit, legal proceeding, administrative proceeding, compliance evaluation, or audit, except for legal or administrative proceedings concerning the enforcement or interpretation of this specific Agreement.
- 16. All references to "days" in this Agreement are calendar days. If any deadline for an obligation scheduled to be performed under this Agreement falls on a weekend or a Federal holiday, that deadline will be extended to the next business day.

III. Technical Violations and Remedies

1. VIOLATION: During the review period, Industria did not provide written notification to OFCCP within 10 working days of awarding any construction subcontract in excess of \$10,000 that was made under a covered Federal or federally assisted construction contract as required by 41 C.F.R. 60-4.2(d)3.

REMEDY: Industria will notify, in writing, the OFCCP Regional Office that covers the geographical area in which the work will be performed. The notification will be sent within 10 working days of awarding a Federal or federally assisted construction subcontract in excess of \$10,000.

2. VIOLATION: During the review period, Industria did not include the Standard Federal Equal Employment Opportunity Construction Contract Specifications in its construction subcontracts in excess of \$10,000 as required by 41 C.F.R. 60-4.3(a).

REMEDY: Industria will include the Standard Federal Equal Employment Opportunity Construction Contract Specifications in all Federal and federally assisted construction subcontracts in excess of \$10,000.

3. VIOLATION: During the review period, Industria did not provide written notification to minority and female recruitment sources and to community organizations when it or its unions had employment opportunities available as required by 41 C.F.R. 60-4.3(a)7.b.

REMEDY: Industria will provide written notification to minority and female recruitment sources and to community organizations when it or its unions have employment opportunities available and will maintain any responses received from these organizations.

IV. OFCCP Monitoring Period

1. **Recordkeeping.** Industria agrees to retain all records relevant to the violation(s) cited in Section III above and the reports submitted in compliance with Paragraph 2, below. These records include underlying data and information such as Human Resources Information System (HRIS) and payroll data, job applications and personnel records, and any other records or data used to generate the required reports. Industria will retain the records until this Agreement expires or for the time period consistent with regulatory requirements, whichever is later.

2. Industria Reports.

A. Schedule and Instructions. Industria will submit the documents and progress report described below to OFCCP Chicago District Compliance Officer, (b) (6), (b) (7)(C) at (b) (7)(C), (b) (7)(E) @dol.gov.

Industria agrees to furnish OFCCP with the following reports during the Monitoring Period according to the following schedule:

Progress Report will be due June 1, 2023, and cover the period from the effective date of this Agreement through March 31, 2023.

Progress Report 1 shall include:

Pursuant to Violation 1:

Documentation that Industria sent written notification to the OFCCP Regional Office covering the geographical area in which the work was to be performed within 10 working days of awarding a Federal or federally assisted construction subcontract in excess of \$10,000.

Pursuant to Violation 2:

Documentation that Industria included the Standard Federal Equal Employment Opportunity Construction Contract Specifications in all Federal and federally assisted construction subcontracts in excess of \$10,000.

Pursuant to Violation 3:

Documentation of minority and female recruitment sources used, correspondence sent to and responses received from minority and female recruitment sources and to community organizations along with other actions taken in conjunction with any union referrals. Job opportunities will be listed with sources at least 10 days prior to hire date, when possible. Industria will document and retain all actions taken including the


recruitment source contacted, date of contact, job openings listed, name of contact person and disposition.


Industria and OFCCP have a common interest in the information being provided in the report to this Agreement. To the extent any of the reports Industria provides in accordance with this Agreement are trade secrets, commercial, and/or financial in nature, and customarily kept private or closely-held, and Industria believes should remain confidential under Exemption 4 of the Freedom of Information Act (FOIA) in the event of a FOIA request, Industria will provide such reports to OFCCP marked as "Confidential". In the event of a FOIA request, OFCCP will promptly notify Industria of the FOIA request and provide Industria an opportunity to object to disclosure. OFCCP will withhold disclosure of such reports to the maximum extent allowable by law.

3. Close of Monitoring Period and Termination of Agreement. This Agreement shall remain in effect until the monitoring period is completed. The monitoring period will close once OFCCP accepts Industria's final progress report as set forth in Section II, Paragraph 9 above. If OFCCP fails to notify Industria in writing within sixty (60) days of the date of the final progress report that Industria has not fulfilled all of its obligations under the Agreement, OFCCP will be deemed to have accepted the final report and the Monitoring Period and this Agreement will terminate. If OFCCP notifies Industria within the allotted time that it has not fulfilled all of its obligations, this Agreement is automatically extended until the date that OFCCP determines Industria has met all of its obligations under the Agreement.


