Early Resolution Conciliation Agreement - Addendum
Between the
U.S. Department of Labor
Office of Federal Contract Compliance Programs
And
US Foods, Inc.

I. Preliminary Statement

The Office of Federal Contract Compliance Programs ("OFCCP") and US Foods, Inc. ("US Foods") entered into an Early Resolution Conciliation Agreement ("Agreement") on July 25, 2019, to resolve alleged hiring discrimination violations for female applicants in Selector positions at three establishments.¹ As part of the Agreement, US Foods agreed to proactively facilitate compliance with Executive Order 11246, as amended, ('E.O. 11246" or the "Executive Order"), in the hiring of Selectors at six establishments ("Covered Facilities").² In relevant part, US Foods agreed to "conduct adverse-impact analyses of Selector hiring at each of the Covered Facilities," as well as to "implement remedies to correct any statistically significant disparities in hiring and report to OFCCP on actions taken." Agreement, Part IV.11. In keeping with the reporting requirements of the Agreement, US Foods submitted various progress reports. During evaluation of the third progress report, OFCCP learned that US Foods continued to observe statistically significant disparities between male and female hiring rates for Selector positions at each of the Covered Establishments during the period of July 22, 2021 through July 21, 2022. US Foods agreed to remedy these disparities as outlined below. OFCCP has not issued any formal notice of alleged violations regarding the Agreement and there have not been any adjudicated findings.

In the interest of resolving the alleged violations without engaging in further legal proceedings and in exchange for sufficient and valuable consideration described in this document, OFCCP and US Foods (collectively "the parties") enter into this Addendum of the Early Resolution Conciliation Agreement ("Addendum") and its attachments, and the parties agree to all the terms therein.

The attachments to this Addendum are deemed incorporated into the Agreement.

II. General Terms and Conditions

- 1. This Addendum incorporates by reference and amends the Early Resolution Conciliation Agreement (Agreement) the parties entered on July 25, 2019. The Addendum supplements and does not supplant the Agreement. Unless otherwise noted, all definitions, obligations, and terms and conditions in the Agreement remain in force, in their original unmodified form, for the term of the Agreement as extended per Part II.11 and VII.2.A below.
- 2. In exchange for US Foods' fulfillment of all its obligations in this Addendum, OFCCP will not institute administrative or judicial enforcement proceedings under E.O. 11246 based on the violations alleged in Part III below and pertaining to the contents of the second and third progress report submissions. However, OFCCP retains the right to initiate legal

proceedings to enforce the Agreement and Addendum if US Foods violates any provision of this Addendum. Nothing in this Addendum precludes OFCCP from initiating enforcement proceedings based on future compliance evaluations or complaint investigations.

- 3. Nothing in this Addendum relieves US Foods of its obligation to fully comply with the requirements of E.O. 11246, Section 503, VEVRAA, their implementing regulations, or other applicable laws requiring nondiscrimination or equal employment opportunity through affirmative action.
- 4. US Foods and OFCCP agree that any release of claims required by this Addendum will only pertain to claims under E.O. 11246.
- 5. US Foods agrees that it will not retaliate against any potential or actual beneficiary of this Addendum or against any person who files a complaint, who has provided information or assistance, or who participates in any manner in any proceeding in this matter.
- 6. The parties understand the terms of this Addendum and enter into it voluntarily.
- 7. This Addendum, including its attachments, constitutes the entire Agreement and represents the complete and final understanding of the parties but does not supplant the original Agreement of July 25, 2019. Any modifications or amendments to this Addendum or the Agreement must be agreed upon in writing and signed by all parties. If an administrative error is found, OFCCP will work in good faith with all parties to make the corrections.
- 8. This Addendum becomes effective on the day it is signed by the Director of the Southeast Region (Effective Date).
- 9. This Agreement does not constitute an admission by US Foods of any violation of the Executive Order, nor has there been an adjudication on the merits regarding any such violation.
- 10. This Addendum is limited to the facts of this case. Neither this Addendum, nor any part of the negotiations that occurred in connection with this Addendum, shall constitute admissible evidence with respect to any OFCCP policy, practice or position in any lawsuit, legal proceeding, administrative proceeding, compliance evaluation or audit, except for legal or administrative proceedings concerning the enforcement or interpretation of the specific Agreement.
- 11. US Foods and OFCCP agree that the Agreement shall be extended for two years from the Addendum effective date. In exchange for US Foods' fulfillment of all obligations in Parts IV-VII of the Addendum, OFCCP further agrees not to initiate any new audits at the Covered Facilities until at least two years after US Foods submits the final progress report described in Part VII of this Addendum and the OFCCP confirms to US Foods that it has fully complied with the terms of the Agreement.³

- 12. US Foods and OFCCP agree to amend the Agreement progress reporting requirements and report submission dates as described in Part VII of this Addendum.
- 13. All references to "days" in this Addendum, and in the Timeline included as Attachment B, are calendar days. If any deadline for an obligation scheduled to be performed under this Addendum falls on a weekend or a federal holiday, that deadline will be extended to the next business day.

III. Discrimination Allegations

1. OFCCP alleges that US Foods is not in compliance with the nondiscrimination requirements of the equal opportunity clause of E.O. 11246 Section 202 and 41 CFR 60-1.4(a)(1). Specifically, US Foods observed statistically significant differences in the hiring rates of female applicants for Selector positions at six establishments (Covered Facilities) when compared to male applicants during the period of July 22, 2021 through July 21, 2022, resulting in a shortfall of 195 female hires.

IV. Financial Remedy

1. Progress Report Settlement Fund

a. **Progress Report Amounts.** The total Progress Report Settlement Fund amount includes at least \$324.58 in back pay and \$36.06 in interest for each class member to resolve the alleged specific violation set forth above, for at least a total of \$360.64 per class member. The Settlement Fund is a negotiated amount that represents restitution for estimated back pay and accrued interest. US Foods' share of statutory taxes/contributions on the portion representing back pay (such as Federal Income Contributions Act (FICA) and Federal Unemployment Tax Act (FUTA) or other federal, state and/or local taxes) is not part of the Settlement Fund. US Foods will be responsible for any banking account fees related to the Settlement Fund.

2. Allocation

a. **Total Amount to be Allocated.** The back pay and interest amounts of the Settlement Fund, will be distributed as explained in this Part to all Affected Applicants (identified in Attachment A) who timely respond to the Notice Process as explained below, and whose eligibility is verified (hereinafter "Class Member(s)"). Individual shares will include appropriate deductions for each individual's share of payroll deductions required by law on the portion representing back pay only, such as federal (FICA), state or local insurance premiums or taxes.

b. **Affected Applicants Eligible to Receive Payments.** The Settlement Fund will be distributed equally to all Class Members. These individuals will be listed on the Final List of Class Members ("Final List"). The process of determining the Final List is explained below under Notice Process. All Class Members are entitled to their share of

the monetary settlement regardless of whether they are currently interested in employment with US Foods.

- c. Payments to Class Members. OFCCP will provide US Foods a list of the payment amount for each Class Member on the Final List by the date set forth on the Timeline. US Foods will issue checks or make electronic payments to each Class Member in the stated amount, along with appropriate tax reporting forms (such as W-2 and Internal Revenue Service (IRS) Form 1099) by the date set forth on the Timeline. OFCCP will receive timely documentation of all payments made and any payments returned undelivered, or any checks not cashed, as set forth on the Timeline. Reasonable efforts will be made to ensure that all Class Members listed on the Final List have an opportunity to claim their portion of the settlement. Where it is determined that a Class Member did not receive a check or that a check was lost, OFCCP and US Foods will work together to provide a replacement check before any funds are redistributed to other class members. Any checks that remain uncashed 120 days after the initial date checks were mailed to the Class Members will be void. With respect to any uncashed funds, US Foods will deposit the monies within thirty (30) days with the state agency responsible for unclaimed funds of the last known address for the Eligible Individual, in accordance with any and all applicable laws and regulations. 5 US Foods will notify each Class Member whose check is sent to the state agency in charge of unclaimed property. No portion of the settlement fund shall revert back, directly or indirectly, to US Foods or any affiliate.
- d. **Tax Payments, Forms and Reporting.** US Foods will pay US Foods' share of social security withholdings and any other tax payments required by law from additional funds separate from the Settlement Fund. US Foods shall mail to each Class Member an IRS Form W-2 for that portion of the payment representing back pay and an IRS Form 1099 for that portion of the payment representing interest. These IRS forms will be provided to the Class Members either at the time of payment, electronically or with the settlement checks, or in time required by law. No Class Member will be required to complete a W-4 or W-9 in order to receive payments under this settlement.⁶ Pursuant to the Tax Cuts and Jobs Act (TCJA) OFCCP will report to the IRS via a form 1098-F when an employer (or individual) is required to pay fines, penalties, restitution, remediation, or other costs in excess of \$50,000 as a result of a violation of law or an investigation or inquiry into a violation of law.⁷

3. Notice Process

- a. **OFCCP and US Foods Obligations under the Notice Process.** The Notice Process set forth in this Addendum is intended to provide Affected Applicants a meaningful opportunity to understand their rights and obligations and act on them in a timely manner. This includes providing notice in multiple relevant languages to the affected workers upon request and providing technical assistance to Affected Applicants seeking information about their rights and obligations under this Addendum. As specified in the Timeline and as otherwise necessary to fulfill this Addendum, US Foods and OFCCP will regularly meet and confer in person, by phone and/or by email on the notice process to determine how best to carry out the Notice provisions of this Addendum, and to decide whether any activity, deadline or document should be modified. OFCCP and US Foods agree not to unreasonably withhold consent to reasonable modifications proposed by either party.
- b. **Notice Documents.** US Foods will distribute Notice Documents contained in Attachment C to Affected Applicants identified in Attachment A. The Notice Documents include the Notice, Information Verification & Employment Interest Forms, and Release of Claims. The Notice Documents will make clear the information about the settlement is being provided by or on behalf of the U.S. Department of Labor. As specified in the Timeline and as otherwise necessary to fulfill this Addendum, the parties will meet and confer on any reasonable modifications of the Notice Documents or additions to the materials distributed by US Foods, if proposed by either party.
- c. **Timeline.** Attachment B sets forth the agreed Timeline for the Notice Process and for the parties' other obligations under this Addendum. The parties will meet and confer on any reasonable modifications to the Timeline proposed by either party.
- d. **Search for Affected Applicants.** OFCCP shall provide US Foods with complete contact information in its possession, or its authority to obtain, for the Affected Applicants by the date set forth in the Timeline.
- e. **Distribution of Mail Notice to Affected Applicants.** US Foods will provide initial notice by regular first-class mail. US Foods will send copies of all the Notice Documents as defined above, including a postage-paid return envelope, by first class mail to the most recent known mailing address for each Affected Applicant, by the date set forth in the Timeline. If envelopes from the initial mail notice are returned with forwarding addresses, US Foods will re-mail the Notice Documents within five (5) days of receipt of the forwarding address.

US Foods will notify OFCCP of all letters returned as undeliverable as specified in the timeline and will re-mail the Notice Documents to Affected Applicants for whom OFCCP provides an updated address within five days of receiving such an address from OFCCP.

Per the Timeline, US Foods will provide OFCCP the names of the Affected Applicants who did not respond to the Notice Documents, failed to return both forms, or failed to sign a form as required. Based on the response to the initial notice, the parties will meet

and confer by the date set forth in the Timeline to assess the results of the initial notice and to ensure that the second round of notice maximizes the potential response rate. US Foods will send a second mail notice to Affected Applicants with valid addresses who fail to respond to the first notice by the date set forth in the Timeline unless the parties agree otherwise.

- f. **Notice Deadline.** The final deadline for any Affected Applicant to respond to the notice is set forth in the Timeline. The parties will prominently display this deadline on all materials they distribute in paper or online form regarding this Addendum and explain that failure to respond by this deadline will result in a forfeiture of any relief provided by the ERCA Addendum.
- g. **Technical Assistance.** The parties will timely respond to any inquiries from Affected Applicants using information consistent with this Addendum and the Notice Documents and will document all inquiries and the result. OFCCP will provide contact information for individuals to contact OFCCP regarding this Addendum. The parties will prominently display this contact information on all materials they distribute in paper or online form regarding this Addendum. US Foods will provide OFCCP's contact information to any Affected Applicant as appropriate.
- h. Exchange of Information Regarding Affected Applicants. US Foods and OFCCP will timely exchange information regarding Affected Applicants, including updated contact information and the results of any technical assistance provided.
- i. Final List of Class Members. The Final List will include all Affected Applicants who timely respond to the Notice and submit the Verification of Information & Employment Interest Form and Release of Claims Form by the deadline set forth in the Timeline and whose eligibility is verified by OFCCP. The parties will establish the Final List by the date set forth in the Timeline. The parties will meet and confer on any outstanding issues or questions regarding the Final List. Either party may identify additional potential Affected Applicants who may have been erroneously excluded from the original or any subsequent list. OFCCP shall make the final determinations of eligibility but will make every effort to negotiate in good faith to resolve any dispute about the Final List. US Foods will provide to OFCCP any information necessary to determine the Final List.
- j. **Documentation of Payments.** By the deadline set forth in the Timeline, US Foods will provide OFCCP with copies of cancelled checks or electronic documentation of all payments to Class Members, including the amounts paid, the date payment was sent, the date payment was received, or the check cashed, and any uncashed or returned checks. In the event of any uncashed funds after the distribution, US Foods will submit documentation showing that uncashed funds have been deposited with the respective unclaimed state agency responsible for unclaimed funds.
- k. **US Foods' Expenses.** US Foods will pay all expenses associated with carrying out its duties pursuant to this Part from funds separate and apart from the amount designated in this Addendum for the Settlement.

V. Additional Individual Relief

1. **Description of Job Opportunities.** As vacancies occur in Selector positions, US Foods shall make bona fide job offers with retroactive seniority to Class Members who have expressed interest in employment and are not currently employed in the job at issue by US Foods until 195 Class Members are hired in Selector positions or until the list of Class Members expressing an interest in employment is exhausted, whichever comes first. US Foods will make its best effort to distribute the 195 female hires at the following establishments: at least 23 female hires in Fort Mill, South Carolina, at least 98 female hires in Lexington, South Carolina, at least 7 female hires in Manassas, Virginia, at least 17 female hires in Port Orange, Florida, at least 15 female hires in Tampa, Florida and at least 35 female hires in Zebulon, North Carolina. Class Members will have priority in incoming Selector hiring groups until 195 Class Members are hired or until the list of Class Members expressing an interest in employment is exhausted, whichever comes first. As vacancies occur in Selector positions, US Foods shall contact the Class Members with a written conditional job offer in the order in which they submitted their updated employment application. 8 The conditional job offer letter will include language explicitly stating to Class Members that they are receiving this job offer as part of a settlement between US Foods and the U.S. Department of Labor. US Foods will make at least two attempts by phone and two attempts by email to contact qualified Class Members who have expressed an interest in employment with US Foods on the Information & Employment Verification Interest Form.

The report-to-work date for Class Members hired pursuant to this Addendum shall be the next available Selector start date after the candidate passes US Foods' post-offer, pre-employment background check and drug screen. The Class Member must report to work on the day designated or provide US Foods notice of good cause for their absence on or before that date. ⁹ If good cause is provided, the Class Member must report to work on the next scheduled start date. Otherwise, US Foods may withdraw the job offer and shall be under no obligation to hire the Class Member under this Addendum but remains obligated to hire until 195 Selector positions are filled, or the list of Class Members is exhausted, whichever comes first.

US Foods agrees to pay Class Members hired under this provision at least the current entry level wage for Selector positions at each establishment and provide all regular and on-the-job training currently provided to employees in that position. Class Members shall receive retroactive seniority as a Selector back to the date of their original application for job retention purposes only, to the extent that seniority is a factor in layoff decisions.

2. **Reporting.** US Foods will document the job offers and hires, including job offers made, reason(s) for rejection, and Class Members hired and terminated during the monitoring period as set forth in Part VII, OFCCP Monitoring Period, below.

VI. Modifications to Employment Practices and Other Non-Monetary Relief

1. Compliance. US Foods shall not discriminate against any employee or applicant for employment because of race, color, religion, sex, sexual orientation, gender identity, national origin, disability, or status as a protected veteran. US Foods will ensure that all applicants are afforded equal employment opportunities. US Foods agrees to continue and/or to implement the corrective actions detailed below.

2. Revised Hiring Process.

- a. **Maintain Non-Discriminatory Selection Procedures.** US Foods agrees to comply with all OFCCP regulations concerning selection procedures, including 41 CFR 60-3. US Foods will not use any selection procedure that has an adverse impact, as defined in 41 CFR 60-3.4D, on applicants of a particular race, ethnicity, or sex unless it properly validates the procedure pursuant to these regulations and can show that the selection procedure is job related and consistent with business necessity.
- b. **Review and revisions required.** Effective July 1, 2023, US Foods has agreed to and implemented a revised hiring process for Selector positions at each Covered Facility establishment. As part of the newly implemented hiring process, US Foods agrees to use a revised candidate interview form at the Covered Facilities focused on job related competency questions. Further, US Foods agrees that the revised interview will be conducted by trained recruiters at each establishment. US Foods will ensure all policies and qualifications standards are uniformly applied to all applicants.
- c. **Warehouse Tour.** As part of the newly implemented process, US Foods agrees to the use of trained company officials in leading and directing the in-person post-offer enhanced warehouse tour for Selector candidates at each of the Covered Facilities and, to the extent possible, conduct warehouse tours in a group setting. ¹⁰

3. Training.

- a. **Revised Hiring Process.** Within 60 calendar days of the Effective Date of this Addendum, US Foods will train every individual involved in recruiting, selecting, interviewing, tracking, or touring applicants for Selector positions pursuant to the revised hiring process and OFCCP's recordkeeping requirements. The training will include instruction including, but not limited to: the proper implementation of the recruitment, tracking, and selection procedures; neutral application of the specified qualifications and criteria that will be used at each step in the hiring process; procedures to be used to document the decisions made at each step in the hiring process; and the procedures to be used to ensure that documents are retained in accordance with 41 CFR 60-1.12(a) and Part 60-3.
- b. The training must ensure that recruiters and managers who have completed the training understand and can implement the requirements to (1) follow

- nondiscriminatory recruitment and hiring practices, (2) consistently and fairly implement the Revised Hiring Process, and (3) properly document the results of their decisions and retain appropriate records.
- c. US Foods shall share its non-discrimination, anti-harassment, and anti-retaliation policies with new Selectors at the Covered Facilities.
- d. **Equal employment opportunity obligations.** Within 60 calendar days of the Effective Date of this Addendum, US Foods will meet with management at the Covered Facilities and all individuals responsible for the recruitment and selection process at the Covered Facilities to review its equal employment obligations and nondiscrimination policies related to the selection process. US Foods will document and maintain a record of the date of each meeting, and the name and job title of each employee attending each meeting.
- 4. Monitoring. Consistent with the ERCA, US Foods agrees to monitor selection rates at each step of its selection process for Selector positions at each of the Covered Facilities. Where it is determined that a selection procedure or qualification has an adverse impact, as defined in 41 CFR 60-3.4D, on the hiring of female applicants, US Foods will eliminate the procedure, choose an alternative procedure, or validate the procedure in accordance with the Uniform Guidelines on Employee Selection Procedures codified at 41 CFR Part 60-3. Where adverse impact is identified, in the fifth or sixth progress reports and US Foods is unable to demonstrate that the cause of the impact is job-related and consistent with business necessity, US Foods will modify its policies or procedures accordingly to address the cause of the disparate impact. US Foods shall also discuss with OFCCP appropriate job opportunities and remedial relief for affected individuals. US Foods agrees to maintain and make available for inspection records concerning the impact of the selection process for Selector positions. This includes documenting the number of persons hired by sex, the number of applicants who applied by sex, and the number of applicants by sex who participated in and passed each selection procedure utilized. This information will be maintained until the expiration of the Agreement or as long as required by 41 CFR 60-1.12, whichever is later. US Foods will meet its obligation to conduct adverse impact analyses in accordance with the requirements of 41 CFR Part 60-3.
- 5. **Outside Monitoring.** US Foods agrees to continued use of an outside monitor (Consultant) to 1) conduct reviews of policies and procedures, 2) to oversee impact analyses on the hiring process, including assessment of various stages and screens used by US Foods, 3) to suggest potential alternatives, and 4) to monitor impacts of any changes to the hiring process designed to further equal employment opportunity.
- 6. **Recordkeeping**. Pursuant to 41 CFR 60-1.12, US Foods will ensure its recruiters and managers properly document the results of hiring decisions made pursuant to the revised hiring policies and procedures, and properly maintain all records on the revised policies and procedures including any associated underlying data and information such as, recruitment agreements, advertisements internal and with third party vendors, HRIS and payroll data, job applications, applicant and hire data, disposition codes, interview and

personnel records, and any other records or data used to generate the required reports. US Foods will retain the records until the Agreement expires or for the time period consistent with regulatory requirements, whichever is later.

7. Publicize Check-In Line. US Foods agrees to expand trainings and dissemination of the employee Check-in Line for hired Selector class members and Selector employees at the Covered Facilities to report complaints, including those of harassment, discrimination, or retaliation.

VII. OFCCP Monitoring Period

1. **Recordkeeping.** US Foods agrees to retain all records relevant to the violations cited in Part III above and the reports submitted in compliance with Paragraph VII.2, below. These records include underlying data and information such as Human Resources Information System (HRIS) and payroll data, job applications and personnel records, and any other records or data used to generate the required reports. US Foods will retain these records until the Agreement expires or for the time period consistent with regulatory requirements, whichever is later.

2. US Foods Reports.

- A. **Schedule and Instructions:** US Foods agrees to extend the term of the Agreement for two years from the Effective Date of this Addendum. During that time, US Foods will furnish OFCCP with the remaining fourth and fifth progress report and an additional progress report according to the following schedule:
 - i. **Progress Report 4:** Due March 18, 2024, covering the period from of July 22, 2022 through July 21, 2023. 11
 - ii. **Progress Report 5:** Due September 16, 2024, covering the period of July 22, 2023 through July 21, 2024.
 - iii. **Progress Report 6:** Due September 16, 2025, covering the period of July 22, 2024 through July 21, 2025.

US Foods will submit reports to George Rouse, III., District Director, Charlotte District Office at (b) (6), (b) (7)(C) @dol.gov; with a copy to Regional Liaison @dol.gov.

US Foods and OFCCP have a common interest in the information being provided in the reports pursuant to this Addendum and the Agreement. To the extent any of the reports US Foods provides in accordance with this Addendum and the Agreement are customarily kept private or closely held, and US Foods believes

should remain confidential in the event of a FOIA request, US Foods will provide such reports to OFCCP marked as "Confidential." In the event of a FOIA request, OFCCP will treat any such documents received as confidential documents to the extent permissible under law.

- B. Reporting on Financial Remedy. Within the prescribed timeframes, US Foods will submit all documents and information referenced in Part IV of the Addendum, including but not limited to names of Class Members who received a distribution pursuant to this Addendum, and for each such Class Member, the number and the amount of the check and the date the check cleared the bank. US Foods will provide OFCCP with copies of all canceled checks upon request.
- C. **Reports on Job Offers:** In Progress Report 5 & 6, US Foods will report on all job offers and hires made pursuant to the Addendum until all of the job opportunities for the Covered Facilities are filled or the list of Class Members expressing interest in the positions is exhausted. This includes:
 - i. A list of all Class Members who expressed an interest in employment by name, gender, and date of interest.
 - ii. Documentation of all job offers made to Class Members, including the name, the gender of individuals offered jobs, the date of their class member requisition submission, the date of the offer, the date the offer was accepted or rejected, starting dates, and the starting pay rate.
 - iii. A list of Class Members who expressed interest in job offers who did not successfully complete the post-offer hiring process, including the name, the gender of these individuals, the date of their class member requisition submission, if any, and the reason US Foods determined they did not successfully complete the post-offer hiring process along with all relevant documentation (e.g., failure to submit and/or satisfy pre-employment screening, such as drug screening, and documentation that the Class Member declined a job offer). This includes individuals who did not receive job offers because all available positions were filled.
 - iv. A list and supporting documentation of Class Members who were hired and terminated during the life of the Agreement, including the reason for the termination.
 - v. Documentation of the number of available positions remaining to be filled and the number of Class Members still on the list.
 - vi. If US Foods has not filled all of the positions specified in this Addendum by the Progress Report date, documentation of the reason this action is not complete and the good faith efforts being taken and planned for the next reporting period to complete it.

- vii. If US Foods fails to meet its hiring obligations under this Addendum by the close of the Monitoring Period, OFCCP reserves its rights under Part II, Paragraphs 10 and 12 of the Agreement 12 to extend the monitoring period or to pursue enforcement remedies.
- D. Reports on Modifications to Personnel Practices. In each Progress Report, US Foods will report on all modifications of personnel practices made through the date of that Progress Report pursuant to the Addendum and provide documentation of its compliance with the remedy provisions of this Addendum. If any of the relevant documents, such as job postings or policies, have not been modified since being provided during a prior reporting period, a statement to that effect is sufficient. The reports must include:
 - i. Documentation of the implementation of and modifications to the Revised Hiring Process described in Part VI, Paragraph 2.
 - ii. Documentation of the training on the Revised Hiring Process and equal employment opportunity obligations described in Part VI, Paragraph 3. The documentation must include the name, job title, and establishment location of each employee attending the training discussed in Part VI, Paragraph 3a, the date of the training; the name, job title, and establishment location of each employee attending each meeting discussed in Part VI, Paragraph 3b, and the date of each meeting; the name, job title, and establishment location of each employee attending each meeting discussed in Part VI, Paragraph 3c and 3d.
- E. Within the prescribed timeframes, US Foods will submit all documents and information referenced in Parts IV-VI.
- F. In the fifth Progress Report, a list in MS Excel format of Affected Applicants who responded timely to the Notice Documents in accordance with the Addendum during the Progress Reporting period.
- G. In the fifth Progress Report, copies of the Information Verification & Employment Interest Form and Release of Claims Form submitted by each Affected Applicant during the Progress Reporting period.
- H. In each Progress Report, supporting documentation and a statement attesting that all Selector employees have been notified of the employee Check-In Line.
- I. In each Progress Report, monitoring reporting consistent with the progress reporting requirements as prescribed in the ERCA.
- 3. Close of Monitoring Period and Termination of Agreement. This Addendum incorporated into the Agreement shall remain in effect until the monitoring period is completed. The monitoring period will close once OFCCP accepts US Foods' final progress report as set forth in Part II, 11 & 12 of the Agreement. If OFCCP fails to notify US Foods in writing within sixty (60) days of the date of the final progress report that

US Foods has not fulfilled all its obligations under the Agreement, OFCCP will be deemed to have accepted the final report and the Monitoring Period and the Agreement will terminate. If OFCCP notifies US Foods within the allotted time that it has not fulfilled all its obligations, the Agreement is automatically extended until the date that OFCCP determines US Foods has met all of its obligations under the Agreement.

VIII. Signatures

The person signing this Early Resolution Conciliation Agreement Addendum on behalf of US Foods, Inc. personally warrants that he is fully authorized to do so, that US Foods has entered into this Addendum voluntarily and with full knowledge of its effect, and that execution of this Addendum is fully binding on US Foods.

The U.S. Department of Labor's Office of Federal Contract Compliance Programs (OFCCP) is the government agency responsible for enforcing the equal employment opportunity and affirmative action requirements that apply to federal contractors. On July 25, 2019, OFCCP and US Foods entered into an Early Resolution Conciliation Agreement (ERCA) regarding alleged hiring discrimination against female applicants for Selector positions. The ERCA required future monitoring and reporting on hiring for Selector positions. As a result of recent ERCA reporting, US Foods identified additional hiring disparities against female Selectors that it agreed to remedy. US Foods has not admitted to any violation of E.O. 11246 and there has not been any adjudicated finding that US Foods violated any laws. By signing this agreement, I agree that I have been made whole for any claim that could have been brought under Executive Order 11246, as amended, relating to my non-selection with US Foods through the Effective Date of this Release.

II.

I understand that US Foods denies that it treated me unlawfully or unfairly in any way and that US Foods entered into an Early Resolution Conciliation Agreement Addendum with the U.S. Department of Labor, Office of Federal Contract Compliance Programs (OFCCP) and agreed to make the payment described above to resolve alleged disparities in hiring and to resolve the matter without further legal proceedings. I further agree that the payment of the aforesaid sum by US Foods to me is not to be construed as an admission of any liability by US Foods.

III.

I declare that I have read this Release and that I have had a full opportunity to consider and
understand its terms and to consult with my advisors and seek legal advice. I further declare that
I have decided of my own free will to sign this Release.

IV.

I understand that if I do not sign this Release and return it to the contact listed on the enclosed Notice to Affected Applicants, by the deadline listed on the Notice, I will not be entitled to receive any payment (less deductions required by law) from US Foods.
