<sup>2</sup> Exemption 7(C), 5 U.S.C. § 522 (b)(7)(C), provides protection for law enforcement information the disclosure of which "could reasonably be expected to constitute an unwarranted invasion of personal privacy."

<sup>3</sup> Exemption 5, 5 U.S.C. § 522 (b)(5), permits the withholding of records reflecting deliberative materials such as advisory opinions and recommendations, and reflecting privileged communications and attorney work product.

<sup>4</sup> Exemption 4, 5 U.S.C. § 522 (b)(4), permits the withholding of records to protect "trade secrets and commercial or financial information obtained from a person [that is] privileged or confidential."
