Application Executive Summary

The NH Department of Transportation is requesting a total of \$3,736,377 in ?5311 Non-Urbanized Area Formula funds. \$598,266 is from the FFY16 apportionment and \$3,138,111 is from the FFY18 apportionment.

Requested grant funds will provide funding for the following two projects:

Project 1 ? Includes Federal funds in the amount of \$3,367,377 for five ?5311 rural transit providers for Project Administration, Capital PM, Capital ADA and Operating assistance for State Fiscal Year 2019. The Federal amount consists of FFY 2018 rural apportionment (\$4,210,814 less 10% State Admin, less 15% intercity less \$20,000 transferred to Vermont Agency of Transportation (VAoT) = \$3,138,111) plus \$229,266 FFY16 5311(f) funds that are not needed to meet the intercity bus service needs of the state.

NHDOT has certified that the intercity bus service needs in the state have been met (see attached letter). As a result, \$229,266 of FFY16 5311(f) funds will be used for other purposes. Additionally, 15% of the ?5311 apportionments from FFY17 and FFY18 are not included in this application. These funds will be applied for in the after the NH Statewide Transit Assessment Study is completed. This study, to be completed by July 2019, will identify intercity bus needs.

Project 2 ? Includes Federal funds in the amount of \$369,000 of FFY 2016 ?5311(f) Intercity carryover for operating assistance for Concord Coach Lines for State Fiscal Year 2019 and part of State Fiscal Year 2020. Operating funds will be used for Intercity routes to North Conway, Berlin and Littleton.
