This is an FFY 2020 Section 5311(c) CARES Act application in the amount of \$1,512. Per the CARES Act, the grant requests 100% federal share. This application utilizes CARES Act funding to prevent, prepare for, and respond to coronavirus. The application scope of work includes transit services for the Pojoaque Pueblo who contracts with NCRTD to provide these services. The Pojoaque Pueblo is located in North Central New Mexico and is 7 miles north of the City of Santa Fe in Santa Fe County. The Pojoaque Pueblo is a member of the North Central Regional Transit District. These services will provide greater opportunity for tribal and community members to access employment, medical, educational, and recreational facilities within the service area of the district.

In addition to the 5311(c) CARES funding the Pojoaque Pueblo also was apportioned \$1,643 in FY2020 Full Year Section 5331(c) public transportation on Indian Reservation Formula apportionments which will be applied for separately.

### Project Description

This grant will provide the Pueblo of Pojoaque funds for services as depicted in the District's recently adopted service plan. The Pueblo of Pojoaque is located in North Central New Mexico and is 7 miles north of the City of Santa Fe in Santa Fe County. The Pueblo of Pojoaque is a member of the North Central Regional Transit District. Funds will be used for partial reimbursement of continued transit services.

### Project Benefits

These services will continue to provide greater opportunity for tribal and community members to access employment, medical, educational, and recreational facilities within the service area of the district. Many of the constituents and tribe members do not have any transportation method and rely heavily in public transit.

### Additional Information

Funds will be used for partial reimbursement of continued transit services, the cost associated to run the routes that serve Pojoaque Pueblo is significantly larger than the allocation and it is approximately \$75,000 per year.

### Location Description

Pojoaque Pueblo is one of the six Northern Tewa speaking Rio Grande Pueblos. Archaeological studies of the area have dated inhabitation of the historic Pojoaque Pueblo area as early as 500 AD with a large prehistoric population in the late fifteenth and early sixteenth centuries. The Pueblo of Pojoaque is located in North Central New Mexico and is 7 miles north of the City of Santa Fe in Santa Fe County. The Pojoaque River flows from the Sangre de Cristo Mountains from Nambé Lake westward where it flows into the Rio Grande
