#### Extended Budget Description

Proposed work includes demolition of existing transit stop flatwork, retaining walls, and sidewalks on SR-224 and SR-248. New construction includes improved pedestrian crossing at SR-224 and Homestake Rd., wider sidewalks and replacement of existing retaining walls, upgraded transit shelters, adequate lighting for visibility and safety, solar panels, ADA access improvements and compliance, "NextBus" electronic sign technology, bike and ski racks, and recycle and waste receptacles.
