DETERMINATION

Determination of a Complaint Filed under Title IV of the Labor-Management Reporting and Disclosure Act of 1959

On August 28, 2022, the Secretary of Labor received a complaint alleging violations of Section 401 of the Labor-Management Reporting and Disclosure Act of 1959 (LMRDA), in the regularly scheduled election of officers conducted on April 19, 2018, by United Steelworkers (USW) Local 12-7600-S in Fontana, California.

Pursuant to Sections 402 and 601 of the LMRDA, the Department of Labor conducted an investigation. The investigation disclosed that the union failed to provide adequate safeguards to ensure a fair election in that the local did not uniformly apply the meeting attendance requirement to all local union officer positions, in violation of Section 401(c) of the LMRDA.

Apprised of these findings, USW Local 12-7600-S agreed to conduct new nominations and election of officers under the supervision of the Secretary of Labor, in accordance with Title IV of the LMRDA. The agreed upon remedial election was concluded on February 2, 2023. It is, therefore,

<u>DETERMINED</u>, that there is probable cause to believe that violations of Title IV of the LMRDA occurred which may have affected the outcome of the election conducted by USW Local 12-7600-S on April 19, 2018, but that these violations have been remedied by the new election, conducted in accordance with Title IV of the LMRDA, under the supervision of the Secretary of Labor, on February 2, 2023.

Therefore, civil action under Section 402(b) of the LMRDA to set aside the election conducted on April 19, 2018 is not warranted.


