DETERMINATION

Determination of a Complaint Filed under Title IV
of the Labor-Management Reporting and Disclosure Act of 1959

On November 3, 2022, the Secretary of Labor received a complaint alleging violations of Section 401 of the Labor-Management Reporting and Disclosure Act of 1959 (LMRDA), in the regularly scheduled election of officers conducted on June 21, 2022, by United Auto Workers (UAW) Local 7777 in Detroit, Michigan.

Pursuant to Sections 402 and 601 of the LMRDA, the Department of Labor conducted an investigation. The investigation disclosed that sixteen members were not mailed proper notice of the election, two members were denied the right to vote, and two ineligible non-members voted in the election.

Apprised of these findings, UAW Local 7777 agreed to conduct a new election of officers under the supervision of the Secretary of Labor, in accordance with Title IV of the LMRDA. The agreed upon remedial election was concluded on June 1, 2023. It is, therefore,

DETERMINED, that there is probable cause to believe that violations of Title IV of the LMRDA occurred which may have affected the outcome of the election conducted by UAW Local 7777 on June 21, 2022, but that these violations have been remedied by the new election, conducted in accordance with Title IV of the LMRDA, under the supervision of the Secretary of Labor, on June 1, 2023.

Therefore, civil action under Section 402(b) of the LMRDA to set aside the election conducted on June 21, 2022 is not warranted.
