#### **SECRETARY OF LABOR'S STATUS REPORT**

Plaintiff, **MARTIN J. WALSH**, Secretary of Labor of the United States Department of Labor ("Secretary"), hereby submits the following status report in response to the Court's October 15, 2021 order:

# I. Remaining Parties

The Secretary brought the instant litigation against sixteen defendants for their breaches of fiduciary responsibilities under the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended, 29 U.S.C. § 1001, et seq. The Secretary has resolved all claims against all defendants; as such, there are no remaining claims nor any remaining parties. In summary:

### IV. Request for Status Hearing

The Secretary requests the Court keep the case open and schedule a status conference every six months in order to monitor the court-appointed Independent Fiduciary until the AEU Plan is terminated. After the AEU Plan is terminated, the case may be closed.
