On or about December 21, 2021, at an establishment located at 2610 Ross Avenue in Schofield, Wisconsin, at Facility 2; the employer did not ensure employees implemented energy control application steps prior to allowing them to unjam extruded aluminum from the runout table during production. The Puller was not de-energized prior to an employee entering the gated area of the 8-inch Extrusion Press runout table to engage in the servicing activity of unjamming the extruded aluminum from the runout table rollers, exposing the employee to struck-by injuries from the Puller.

As a result, the remaining applicable energy control elements, involving machine isolation [1910.147(d)(3)], lockout/tagout device application [1910.147(d)(4)], dissipation of residual energy [1910(d)(5)(i)], and verification of isolation [1910.147(d)(6)] were not implemented to protect employees from machine hazards.
