

Penalty Payment – Penalties are due within 15 working days of receipt of this notification unless contested. You will be required to enter your inspection number when making the payment. Payments can be made by credit card or Automated Clearing House (ACH) using your banking information. OSHA does not agree to any restrictions or conditions or endorsements put on any check, money order, or electronic payment for less than the full amount due and will process the payments as if these restrictions or conditions do not exist.

Notification of Corrective Action – For each violation which you do not contest, you must provide **abatement certification** to the Area Director of the OSHA office issuing the citation and identified above. This abatement certification is to be provided by letter within 10 calendar days after each abatement date. Abatement certification includes the date and method of abatement. If the citation indicates that the violation was corrected during the inspection, no abatement certification is required for that item. The abatement certification letter must be posted at the location where the violation appeared, and the corrective action took place or employees must otherwise be effectively informed about abatement activities. 29 CFR 1910.22(a)(1): All places of employment, passageways, storerooms, service rooms, and walking-working surfaces are kept in a clean, orderly, and sanitary condition.

The employer fails to ensure that all places of employment, passageways, and walking-working surfaces are kept in a clean, orderly, and sanitary condition.

a) This most recently occurred on or about November 16, 2022, at an establishment located at 991 Marquette Street in Kewaunee, Wisconsin; employees are exposed to trip and fall hazards while working in the receiving room, aisles 16 and 17, and the aisle endcaps from merchandise, wheeled carts, boxes, and totes that are stored throughout the walking-working surfaces.

To abate this hazard in the future, the employer must ensure that walking-working surfaces in the workplace are kept in a clean, orderly, and sanitary condition.

The employer does not ensure that all emergency exit accesses are at least 28 inches wide at all points.

a) This most recently occurred on or about November 15, 2022, in the receiving room of Dollar General Store No. 6509, located at 991 Marquette Street in Kewaunee, Wisconsin; The emergency exit in the receiving room is inaccessible when its access to it is blocked with two rolltainers, bags of garbage, and a garbage can. Access to the exit is restricted to approximately 16 inches.

b) This most recently occurred on or about November 16, 2022, in the front of the store near the bathroom and front doors of Dollar General Store No. 6509, located at 991 Marquette Street in Kewaunee, Wisconsin; The emergency exit at the front of the store is inaccessible from the restroom. Access to the exit is partially obstructed with wheeled carts loaded with merchandise. Access to the exit was restricted from the bathroom to the front door to approximately 16 and 23 inches.

To abate this hazard in the future, the employer must ensure that all emergency exit accesses are maintained to at least 28 inches wide at all points.

The exit route is restricted to approximately 16 inches.
- b) This most recently occurred on or about November 16, 2022, at Dollar General Store No. 6509, located at 991 Marquette Street in Kewaunee, Wisconsin; The emergency exit route from the bathroom to the front door is inaccessible as it is blocked by two wheeled carts. The exit route is restricted to approximately 16 and 23 inches.

To abate this hazard in the future, the employer must ensure that emergency exit routes are kept free and unobstructed at all times.

29 CFR 1910.303(b)(2): Installation and use. Listed or labeled equipment shall be installed and used in accordance with any instructions included in the listing or labeling.

The employer does not ensure that all electrical equipment is utilized according to the listing or labeling.

a) This most recently occurred on or about November 17, 2022, at an establishment located at 991 Marquette Street in Kewaunee, Wisconsin, in the breakroom; Employees are exposed to electrical fire and shock hazards when a relocatable power tap is series connected into another relocatable power tap.

Dollar General Corporation was previously cited under the name Dolgencorp, LLC dba Dollar General Store #7705 for a SERIOUS violation of this occupational safety and health standard 1910.303(b)(2), which was contained in OSHA inspection number 1333332, citation number 1, item number 1, and was affirmed as final order on March 18, 2022, with respect to a workplace located at 5051 Peach Street, Erie, PA 16509.


If a personal check is issued, it will be converted into an electronic fund transfer (EFT). This means that our bank will copy your check and use the account information on it to electronically debit your account for the amount of the check. The debit from your account will then usually occur within 24 hours and will be shown on your regular account statement. You will not receive your original check back. The bank will destroy your original check, but will keep a copy of it. If the EFT cannot be completed because of insufficient funds or closed account, the bank will attempt to make the transfer up to two times.

Pursuant to the Debt Collection Act of 1982 (Public Law 97-365) and regulations of the U.S. Department of Labor (29 CFR Part 20), the Occupational Safety and Health Administration is required to assess interest, delinquent charges, and administrative costs for the collection of delinquent penalty debts for violations of the Occupational Safety and Health Act.

Interest: Interest charges will be assessed at an annual rate determined by the Secretary of the Treasury on all penalty debt amounts not paid within one month (30 calendar days) of the date on which the debt amount becomes due and payable (penalty due date). The current interest rate is one percent (1%). Interest will accrue from the date on which the penalty amounts (as proposed or adjusted) become a final order of the Occupational Safety and Health Review Commission (that is, 15 working days from your receipt of the Citation and Notification of Penalty), unless you file a notice of contest. Interest charges will be waived if the full amount owed is paid within 30 calendar days of the final order.

Delinquent Charges: A debt is considered delinquent if it has not been paid within one month (30 calendar days) of the penalty due date or if a satisfactory payment arrangement has not been made. If the debt remains delinquent for more than 90 calendar days, a delinquent charge of six percent (6%) per annum will be assessed accruing from the date that the debt became delinquent.

Administrative Costs: Agencies of the Department of Labor are required to assess additional charges for the recovery of delinquent debts. These additional charges are administrative costs incurred by the Agency in its attempt to collect an unpaid debt. Administrative costs will be assessed for demand letters sent in an attempt to collect the unpaid debt.
