a) 37 Vinegold Drive, Mullica Hill NJ: The employer did not ensure that the company worksite Foreman operating a powered industrial truck used at the worksite complied with all applicable requirements as defined in the ANSI B56.1-1969, including but not limited to lowering any load, removing the keys from the machine ignition, etc. prior to exiting the powered industrial truck. The company worksite Foreman, operating a JLG All Terrain Lift, elevated unsecured 4 x 8 sheets of OSB set on the lift's forks, in excess of 13 feet above the ground, and partially set the lift's elevated forks onto a residential structure's pitched roof and then exited the lift to perform sheathing and other related activities. ANSI B56.1 - 1969, Safety Standards for Powered Industrial Trucks, requires that when leaving a Powered Industrial Truck unattended, load engaging means shall be fully lowered, controls shall be neutralized, the key or connector plug removed, etc. Observed on or about 03/08/24.

B. Do not allow anyone to stand or pass under the elevated portion of any truck, whether loaded or empty.

**Interest:** Interest charges will be assessed at an annual rate determined by the Secretary of the Treasury on all penalty debt amounts not paid within one month (30 calendar days) of the date on which the debt amount becomes due and payable (penalty due date). The current interest rate is one percent (1%). Interest will accrue from the date on which the penalty amounts (as proposed or adjusted) become a final order of the Occupational Safety and Health Review Commission (that is, 15 working days from your receipt of the Citation and Notification of Penalty), unless you file a notice of contest. Interest charges will be waived if the full amount owed is paid within 30 calendar days of the final order.

**Delinquent Charges:** A debt is considered delinquent if it has not been paid within one month (30 calendar days) of the penalty due date or if a satisfactory payment arrangement has not been made. If the debt remains delinquent for more than 90 calendar days, a delinquent charge of six percent (6%) per annum will be assessed accruing from the date that the debt became delinquent.

**Administrative Costs:** Agencies of the Department of Labor are required to assess additional charges for the recovery of delinquent debts. These additional charges are administrative costs incurred by the Agency in its attempt to collect an unpaid debt. Administrative costs will be assessed for demand letters sent in an attempt to collect the unpaid debt.
