Dr. Marianne Cloeren is the Medical Director of the Building Trades National Medical Screening Program (BTMed) and an Associate Professor of Medicine in the Division of Occupational and Environmental Medicine at the University of Maryland School of Medicine. She received her MD at Temple University School of Medicine in Philadelphia and her MPH at Johns Hopkins Bloomberg School of Public Health. She is Board-Certified in both Occupational Medicine and Internal Medicine. Dr. Cloeren served on the DOL's Advisory Board on Toxic Substances and Worker Health from 2022-2024.

Dr. John M. Dement provides industrial hygiene and epidemiologic expertise to BTMed. He is a certified industrial hygienist and Professor Emeritus in the Division of Occupational and Environmental Medicine at Duke University. Dr. Dement received a BS in Mechanical Engineering from NC State University, an MS in Industrial Hygiene from the Harvard School of Public Health, and a PhD in Industrial Hygiene/Epidemiology from the University of North Carolina. Dr. Dement served on the DOL's Advisory Board on Toxic Substances and Worker Health from 2018-2022.
