



EEOICPA CIRCULAR NO. 26-01

DATE: August 11, 2026

SUBJECT: Savannah River Site (SRS) Special Exposure Cohort (SEC) Class between January 1, 1991, and December 31, 1993.

The purpose of this Circular is to notify all Division of Energy Employees Occupational Illness Compensation (DEEOIC) staff of a new SEC class designation for the SRS located in Aiken, South Carolina.

Pursuant to the Energy Employees Occupational Illness Compensation Program Act (EEOICPA) and 42 C.F.R. Part 83, a petition was filed with the National Institute for Occupational Safety and Health (NIOSH) on behalf of workers at SRS in Aiken, South Carolina, to be added to the SEC. NIOSH completed the evaluation of the petition and presented its findings to the Advisory Board on Radiation and Worker Health ("the Board") at six of the Board's meetings held between February 24, 2011, and April 29, 2026. On June 17, 2026, the Secretary of Health and Human Services (HHS) received the Board's recommendation to add to the SEC a class of employees who worked at the SRS. On July 8, 2026, the Secretary of HHS recommended the class for addition to the SEC in a report to Congress.

"All construction trade employees of Department of Energy (DOE) subcontractors who worked at the Savannah River Site in Aiken, South Carolina, from January 1, 1991, through December 31, 1993, for a number of workdays aggregating at least 250 workdays, occurring either solely under this employment, or in combination with workdays within the parameters established for one or more other classes of employees included in the Special Exposure Cohort. This class specifically does not include employees of prime contractors of Westinghouse Savannah River Company during this time period."

A copy of the Secretary's letter to Congress recommending the designation is included as Attachment 1. Although Congress had the authority to reject the recommendation within a 30-day time frame, Congress took no action. Therefore, the SEC designation for this class became effective as of August 8, 2026, which was 30 days after the Secretary of HHS designated the class for addition to the SEC in the report to Congress.

This is the third SEC class for workers at the SRS. The first class was the subject of EEOICPA Circular No. 12-08, which covered SRS employees who worked at the SRS in Aiken, SC, between January 1, 1953, and September 30, 1972. The second class was the subject of EEOICPA Circular No. 21-03, which covered SRS employees between October 1, 1972, and December 31, 1990.

To qualify under this new class, the employee must have worked at the SRS in Aiken, SC, for 250 days during January 1, 1991, through December 31, 1993, and meet the additional criteria specified in the above class definition. If the employee does not have 250 workdays at the SRS during the period noted, the case file must be reviewed to determine if additional days in the SEC

can be found by combining days from employment meeting the criteria for other SEC classes and aggregating them together to meet the 250-workday requirement.

While a new SEC class has been added for employees who worked at the SRS, NIOSH intends to use any available internal and external monitoring data that are available for an individual claim (and that can be interpreted using existing NIOSH dose reconstruction processes or procedures). This means that for claims that do not satisfy the SEC membership criteria, a partial dose reconstruction is to be performed by NIOSH.

A copy of the NIOSH letter to affected employees at the facility is included as Attachment 2.

This Circular should be used in conjunction with the Federal (EEOICPA) Procedure Manual (PM) Chapter 14.8 (Version 10). A screening worksheet is included as Attachment 3.

As outlined in the Federal (EEOICPA) PM, the district offices and Final Adjudication Branch (FAB) are to use the comprehensive list provided as the basis for an initial screening of cases associated with all SEC classes. For screening only, the results reflected on the initial screening worksheet must be recorded in ECS using the Screening (SEC/PER/Other) Navigation Panel. From the Screening (SEC/PER/Other) Navigation Panel on the case, select the 'Create' button. Based on the result of the review and in accordance with the 'SEC Class Screening Worksheet,' select the appropriate result of "Likely" if the case is likely an SEC, "Unlikely" if it is unlikely that the case will be an SEC, or "Development Needed" if development is needed. The date of the signed worksheet is recorded in the "Date" field. The reason associated with the SEC is selected in the "Reason" field. For this SEC, the reason is "Rvwd per Circular 26-01 Savannah River Site (1/1/1991-12/31/1993)." If the district office and FAB staff determine that the case is going to be awarded based on an SEC, a positive SEC causation path must be created in the Causation tab found under Development Components in ECS. In the SEC causation path, select the SER and SEF blocks, and enter the dates and the SER Reason and SEF Reason "Rvwd per Circular 26-01 Savannah River Site (1/1/1991-12/31/1993)."

Dear President of the United States Senate:

Pursuant to the Energy Employees Occupational Illness Compensation Program Act of 2000 (EEOICPA) and 42 C.F.R. pt. 83, a petition was filed on behalf of workers at the Savannah River Site, in Aiken, South Carolina, to be added to the Special Exposure Cohort (SEC).

The Centers for Disease Control and Prevention's (CDC) National Institute for Occupational Safety and Health (NIOSH) completed the evaluation of the petition [SEC-00103] for the time period from January 1, 1991, through December 31, 1993, and presented various aspects of its findings and analyses to the Advisory Board on Radiation and Worker Health (the Board) at 6 Board meetings held between February 24, 2011, and April 29, 2026.

The Board considered the petition, and on June 17, 2026, I received the Board's recommendation concerning this petition. I also received the Board's deliberations, findings, and recommendations from the Director of NIOSH and the Senior Official Carrying Out the Delegable Duties of the CDC Director. Based on this information, I have determined that the following employees meet the statutory criteria for addition to the SEC, as authorized under EEOICPA, 42 U.S.C. § 7384q.

"All construction trade employees of Department of Energy (DOE) subcontractors who worked at the Savannah River Site in Aiken, South Carolina, from January 1, 1991, through December 31, 1993, for a number of workdays aggregating at least 250 workdays, occurring either solely under this employment, or in combination with workdays within the parameters established for one or more other classes of employees included in the Special Exposure Cohort. This class specifically does not include employees of prime contractors of Westinghouse Savannah River Company during this time period."

The criteria and findings upon which this designation is based are provided in the enclosed report.

As you may know, a petition to add a class of former employees who worked at the Savannah River Site, Aiken, SC, to the Special Exposure Cohort (SEC) under the Energy Employees Occupational Illness Compensation Program Act (EEOICPA) was received by NIOSH. This letter is to provide you with information about the status of this petition and the effect this petition may have on your claim.

On July 8, 2026, in a report to Congress, the Secretary of the Department of Health and Human Services, Robert F. Kennedy, Jr., recommended the following class of employees be added to the SEC:

"All construction trade employees of Department of Energy (DOE) subcontractors who worked at the Savannah River Site in Aiken, South Carolina, from January 1, 1991, through December 31, 1993, for a number of workdays aggregating at least 250 workdays, occurring either solely under this employment, or in combination with workdays within the parameters established for one or more other classes of employees included in the Special Exposure Cohort. This class specifically does not include employees of prime contractors of Westinghouse Savannah River Company during this time period."

Because Congress took no action within 30 days after receiving the report, the above class was added to the SEC August 8, 2026.

Our records indicate that you, or the energy employee on the claim, worked at the Savannah River Site during the period from January 1, 1991, through December 31, 1993, and were diagnosed with a SEC-specified cancer. Your case will be reviewed to see whether it meets the criteria to be included in this new SEC class.

Because the Department of Labor (DOL) determines whether a case is eligible to be included and receive compensation under SEC classes, your claim will be returned to DOL. DOL will then review the Savannah River Site. Qualification for compensation under the SEC requires certain medical and employment criteria to be met. DOL will let you know the results of this review when it is complete. If you do not meet the criteria for compensation under the new SEC class, DOL will let us know and your case will continue in the dose reconstruction process.

I hope this information is helpful.
