This report to the Committee on Veterans' Affairs of the U.S. Senate and the Committee on Veterans' Affairs of the U.S. House of Representatives has been prepared in accordance with Title 38, United States Code (U.S.C.) § 2021(h)(2). The information required to be reported to the Congress pursuant to section 2021(h)(1) is reported separately, as part of the U.S. Department of Labor's (DOL) Veterans' Employment and Training Service's (VETS) Annual Report to Congress.

This report describes the Homeless Veterans' Reintegration Program (HVRP) administered by VETS and covers awards made in Fiscal Year 2023 for the Program Year (PY) 2023 period (July 1, 2023, to June 30, 2024). It is intended to inform Congress and the public about HVRP grant recipients' vital work helping veterans experiencing or at risk of homelessness obtain meaningful employment and to stimulate the development of effective service delivery systems to address the complex problems they face. A full list of HVRP grant recipients operating during PY 2023 can be found in Appendix I.

This report was prepared using data reported by grant recipients within the Office of Management and Budget (OMB) Control Number: 1293-0014, VETS-701 Competitive Grants Technical Performance Report (TPR) and provided to VETS on a quarterly basis. Additionally, the report utilizes information obtained from DOL's Office of Grants Management (OGM) during the Funding Opportunity Announcement (FOA) application and award process.



## Executive Summary

The U.S. Department of Labor, Veterans' Employment and Training Service (VETS), Homeless Veterans' Reintegration Program (HVRP) was initially codified in 1987 under Section 738 of the Stewart B. McKinney Homeless Assistance Act and is currently codified at Title 38 U.S.C. sections 2021, 2021A, and 2023. As an employment-focused competitive grant program, it is the only federal grant program focused exclusively on competitive employment for veterans experiencing homelessness.

The goals of HVRP are to provide career exploration opportunities, career technical training, placement, and supportive services to veterans experiencing or at risk of homelessness, empowering them to secure good jobs in stable, high-demand occupations, paying livable wages. Additionally, HVRP aims to establish strong partnerships between public, private, and nonprofit organizations, especially those that employ and partner with veterans who have experienced homelessness, to deliver equitable services to marginalized veterans experiencing or at risk of homelessness and assist them in overcoming barriers to employment.

## Introduction

### Program Overview

The HVRP provides services to help veterans experiencing or at risk of homelessness obtain meaningful employment and to stimulate the development of effective service delivery systems to address the complex challenges they face. Specifically, veterans are provided with case management, employment and career training services, and links to supportive services within their communities.

HVRP funds are awarded to eligible entities through a competitive grant process outlined in an annual Funding Opportunity Announcement (FOA). Eligible entities include state and local Workforce Development Boards, Native American governments (federally recognized), Native American organizations (other than federally recognized tribal governments), state agencies, for-profit entities and non-profit organizations, including community- and faith-based organizations, and public, state, and private institutions of higher education.

Successful grant applicants must specifically describe clear strategies to provide needed career exploration opportunities, career training, placement services, and support services to eligible veterans so they may secure good jobs in stable, high-demand occupations earning a living wage. Applicants also must demonstrate effective outreach to veterans experiencing homelessness and build an effective level of collaboration with other programs and entities, such as the U.S. Department of Housing and Urban Development – Veterans Affairs Supportive Housing (HUD-VASH) program; the U.S. Department of Veterans Affairs’ (VA) Grant and Per Diem Program; and VA’s Supportive Services for Veteran Families (SSVF) program.

To support HVRP grant recipients, VETS administers the [National Veterans’ Technical Assistance Center \(NVTAC\)](https://nvtac.org/) (<https://nvtac.org/>), which provides no-cost training and technical assistance to HVRP grant recipients and other organizations dedicated to helping veterans experiencing homelessness find employment. Authorized under 38 U.S.C. § 4109, VETS also administers the [National Veterans’ Training Institute \(NVTI\)](#), which provides a learning ecosystem for veteran service providers and specialized training for grant recipients. NVTI offers no-cost training to HVRP grant recipients on veteran-focused employment programs, HVRP grant management and oversight, veterans’ benefits, case management, and other veteran-centered courses.

### HVRP Funding Overview

VETS received an annual appropriation of \$65.5 million in Fiscal Year (FY) 2023. HVRP funds are awarded on a competitive basis to eligible applicants. The HVRP grant has a 36-month period of performance (PoP), which is incrementally funded on an annual basis at the beginning of each PY. VETS provides the first year of funding at the time of award, and funding for years two and three is received through the Incremental Funding amendment application process.

## Participant Eligibility

HVRP provides services to veterans experiencing homelessness or at risk of homelessness. HVRP participant eligibility criteria include the following categories (as defined in [38 U.S.C. § 2021](#)):

- Homeless veterans (including veterans who were homeless but found housing during the 60-day period preceding the date on which the veteran begins to participate in the program);
- Veterans who, at program entry, are at risk of homelessness within the next 60 days;
- Veterans participating in the U.S. Department of Housing and Urban Development – Veterans Affairs Supportive Housing (HUD-VASH)/Tribal HUD-VASH or Supportive Services for Veteran Families (SSVF) programs;
- Veterans who are receiving assistance under the Native American Housing Assistance and Self Determination Act of 1996 (25 U.S.C. § 4101 et seq.);
- Homeless women veterans and homeless veterans with children;
- Veterans recently released from incarceration who are at risk of homelessness; and
- Veterans described at [38 U.S.C. § 2023\(d\)](#) or any other veterans transitioning from incarceration.

Annual appropriation acts may authorize HVRP grant recipients to serve other veteran populations at risk of homelessness. Continued service to these individuals is contingent upon future appropriation act authorization. During FY 2023, Congress authorized HVRP grant recipients under [38 U.S.C. § 2023](#) to serve veterans recently released from incarceration who are at risk of homelessness.

## Benefits and Services

Each HVRP participant receives customized employment and training services to address their specific barriers to employment. Services may include occupational, classroom, and on-the-job training, as well as job search assistance, placement assistance, and post-placement follow-up services.

## PY 2023 Program Performance and Results

In PY 2023, VETS awarded over \$58 million to 159 grant recipients. Specifically, VETS awarded 72 newly competed grants and approved 87 HVRP grants to receive incremental funding for continuing operations during their three-year PoP. In PY 2023, these awarded grant recipients served 15,974 participants. Over 63 percent of those exiting HVRP were placed into employment with an average hourly wage of \$19.44. In the second quarter after exit,<sup>1</sup> the HVRP employment rate was 31 percent and median quarterly earnings were \$8,840.

<sup>1</sup> Participants who are in unsubsidized employment during the second quarter after exit from the program. Median earnings are calculated based on one quarter's worth of wages (a quarter is 13 weeks).

## HVRP PY 2023 Grant Application Cycle

As a result of the PY 2023 HVRP FOA, VETS received 167 applications. Of the applications received, VETS awarded the 72 newly competed grants in 47 different states, the District of Columbia, and two U.S. territories (Guam and Puerto Rico). More information on grant recipients can be found in **Table 1**, and a complete listing of all grant recipients operating during PY 2023 can be found in Appendix I.

<sup>2</sup> “Returning HVRP recipient” is defined as an organization who was awarded an HVRP grant within the past five program years and was in operation for at least six months prior to any termination action.

<sup>3</sup> “Available funds” are the amount of funds available to award new HVRP grants under the FOA merit review process. VETS was appropriated \$65.5 million. The grants awarded provided more than \$28 million for 72 new three-year grants. VETS also funded an additional \$29 million to 87 organizations in their second or third years of the program.

<sup>4</sup> For the PY 2023 application cycle, VETS had sufficient funding to provide an award to each applicant whose application received a competitive score in the merit review panel process. Out of the 167 total applications received, 66 were non-responsive to pre-screening requirements outlined in the FOA (i.e., missing application components) and were removed from the competition. The remaining 101 applications were scored by merit review panels, of which 72 received an HVRP award based on the review and selection factors outlined in the FOA. The remaining 29 applications did not receive an award.

- August 1, 1990 to August 31, 2001: Gulf War Era I
- September 1, 2001 to present: Gulf War Era II
