

The Uniform National Threshold Entered Employment Rate (UNTEER) was 58.4 percent in 2020. Eleven states and territories failed to meet 90 percent of this threshold (equating to 52.56 percent). The UNTEER was calculated from the 6/30/2020 Workforce Innovation and Opportunity Act (WIOA) data and certified in the Workforce Integrated Performance System (WIPS). UNTEER follows an entered employment calculation, which differs from the current WIOA calculations. Specifically, the figures below represent the percentage of exiters who were unemployed or received notice of termination/layoff at the time of participation and were then employed within the first quarter after exit.
