ORDER DISMISSING APPEAL

On April 28, 2023 appellant, through his representative, filed an appeal from a January 18, 2022 merit decision of the Office of Workers' Compensation Programs (OWCP). The Clerk of the Appellate Boards assigned Docket No. 23-0738.

The Board has duly considered the matter and notes that the Board has jurisdiction to review final adverse decisions of OWCP issued under the Federal Employees' Compensation Act.² For final adverse decisions of OWCP issued on or after November 19, 2008, the Board's

¹ In all cases in which a representative has been authorized in a matter before the Board, no claim for a fee for legal or other service performed on appeal before the Board is valid unless approved by the Board. 20 C.F.R. § 501.9(e). review authority is limited to appeals which are filed within 180 days from the date of issuance of OWCP's decision.³

The 180th day following the January 18, 2022 decision was July 17, 2022. As appellant did not file an appeal with the Board until April 28, 2023, more than 180 days after the January 18, 2022 OWCP decision, the Board finds that the appeal docketed as No. 23-0738 is untimely filed. The Board is without jurisdiction to review the appeal. Appellant has not offered a reason to explain his failure to timely file an appeal with supporting documentation sufficient to establish compelling circumstances. Because there is no final adverse decision issued by OWCP within 180 days of the filing of the instant appeal, the Board concludes that the appeal docketed as No. 23-0738, must be dismissed.⁴ Accordingly,

IT IS HEREBY ORDERED THAT the appeal docketed as No. 23-0738 is dismissed.
