ORDER REMANDING CASE

JURISDICTION

On June 21, 2023 appellant filed a timely appeal from a June 7, 2023 merit decision of the Office of Workers' Compensation Programs (OWCP). The Clerk of the Appellate Boards assigned the appeal Docket No. 23-0904.

On March 21, 2023 appellant, then a 55-year-old health aid and technician, filed a traumatic injury claim (Form CA-1) alleging that on March 16, 2023 she was monitoring a cardiac catheterization while in the performance of duty, when K.S., the assistant nurse manager, asked to see her and led her without warning to a police officer. She asserted that she sustained work-related traumatic mental instability, racial fatigue, elevated blood pressure and pulse rate, anxiety,

headaches, insomnia, nausea, embarrassment, betrayal, isolation, and undue stress. Appellant stopped work on March 16, 2023.¹

By decision dated June 7, 2023, OWCP denied appellant's emotional condition claim, finding that the evidence of record was insufficient to establish fact of injury because she had not established that the events or incident occurred as alleged. It noted that she had not responded to its development questionnaire. Consequently, OWCP found that appellant had not met the requirements to establish an injury as defined by FECA.

The Board has duly considered the matter and concludes that this case is not in posture for decision.

OWCP's procedures provide that cases should be administratively combined when correct adjudication of the issues depends on frequent cross-referencing between files.² For example, if a new injury case is reported for an employee who previously filed an injury claim for a similar condition or the same part of the body, doubling is required.³

The Board notes that appellant's prior claim under OWCP File No. xxxxxx428 also involved an emotional condition claim precipitated by interactions with the same manager. However, appellant's claims have not been administratively combined.

For a full and fair adjudication of appellant's current claim, the case must be remanded for OWCP to administratively combine the current case record with OWCP File No. xxxxxx428.⁴ Following this and other such further development as deemed necessary, OWCP shall issue a *de novo* decision.⁵ Accordingly,
