



The 180th day following the April 30, 2025 decision was October 27, 2025. As appellant did not file an appeal with the Board until March 5, 2026, more than 180 days after the April 30, 2025 OWCP decision, the Board finds that the appeal docketed as No. 26-0367 is untimely filed.<sup>4</sup> The Board is without jurisdiction to review the appeal. Appellant has not explained the failure to timely file an appeal with supporting documentation sufficient to establish compelling circumstances. Because there is no final adverse decision issued by OWCP within 180 days of the filing of the instant appeal, the Board concludes that the appeal docketed as No. 26-0367 must be dismissed.<sup>5</sup> Accordingly.

**IT IS HEREBY ORDERED THAT** the appeal docketed as No. 26-0367 is dismissed.
