Below is a summary of the State of Washington's PIRL submission:

- 79 records were stripped, in order to pass the WIPS edit checks successfully.
- 2,365 records were hardcoded, in order to pass the WIPS edit checks successfully.
- 1,773 records were hardcoded with a value of zero, where the "Highest School Grade Completed" was unavailable.
- 370 records were hardcoded with a value of one, where "NDWG numbers were present" to correct a scripting error.
- 195 records were hardcoded with the "School Status at Program Entry" status, where the "School Status at Exit" status was unavailable.
- 27 records were hardcoded, in order to pass the WIPS edit checks successfully.
- A/RTAA data prior to May 2019 was not available for reporting due to technical issues.
