OVERVIEW

Introduction

The Energy Employees Occupational Illness Compensation Program Act (EEOICPA) was enacted in October 2000. EEOICPA provides benefits under Part B to covered employees or survivors of employees of the Department of Energy (DOE), and private companies under contract with DOE, who have been diagnosed with a radiation-related cancer, beryllium-related disease, or chronic silicosis as a result of their work in producing or testing nuclear weapons. Benefits for uranium workers covered by the Radiation Exposure Compensation Act (RECA) are also provided.

In October 2004, Congress amended the EEOICPA to abolish Part D, wherein the DOE provided assistance to DOE contractor employees or their survivors who were found to have work-related occupational illnesses due to exposure to a toxic substance at a DOE facility. Under a newly created Part E of the EEOICPA, responsibility for coverage for these contract employees was transferred to the Department of Labor (DOL). Claims previously filed with DOE were transferred to DOL. Benefit payments under Part E began in December 2004 and full implementation was accomplished with the issuance of regulations on May 26, 2005. The final regulations for Part E were published on December 29, 2006.

DOL is the lead agency responsible for administering Part B and Part E of the EEOICPA through the DEEOIC. In support of the Part B claims adjudication, the Department of Health and Human Services (HHS), through the National Institute for Occupational Safety and Health (NIOSH), estimates occupational radiation exposure for certain cancer cases and takes action on petitions for adding classes of workers to the Special Exposure Cohort. DOE assists DOL and HHS/NIOSH by providing access to pertinent information on worker exposures, including access to classified data and records necessary to verify covered employment. The Department of Justice (DOJ) assists claimants who have been awarded compensation under RECA to file for additional compensation, including medical benefits under the EEOICPA.

Lump-sum compensation payments of up to \$150,000 to covered employees (or qualified survivors) of the DOE, its predecessor agencies (the Manhattan Project and the Atomic Energy Commission) and certain agency vendors, contractors and subcontractors are provided under Part B of EEOICPA. In addition, individuals (or qualified survivors) already found eligible for benefits for illnesses covered under Section 5 of the RECA are eligible for supplemental payments up of \$50,000.

Wage loss compensation and compensation based on whole-person impairment to DOE contractor employees are provided under Part E of the EEOICPA. Part E also provides lump sum compensation payments in the amounts of \$125,000, \$150,000, or \$175,000 to eligible survivors. Medical benefits for accepted conditions are payable under both Parts B and E. Part E benefits are also extended to individuals and survivors who worked at RECA Section 5

facilities. DOJ is authorized to make payments from the EEOICPA Compensation Fund for benefits DOJ awards under Section 5 of the RECA.

EEOICPA Performance

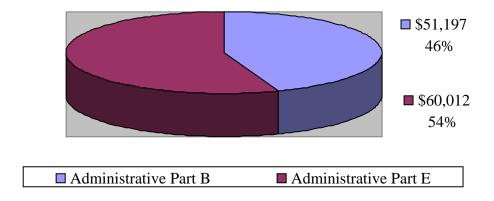
For FY 2010, DEEOIC has established performance targets of 150 days to process an initial claim under Part B and 190 days to process an initial claim under Part E. The Part B goal is an improvement of 10 days below the established goal for FY 2009. The Part E goal is an improvement of 5 days below the established goal for FY 2009. The goal for processing final decisions has been increased to 89%.

Cost Model

The funding request for Part B is \$51,197,000 for FY 2010. This is an increase of \$1,543,000 from the FY 2009 budget estimate of \$49,654,000. The funding estimate from the indefinite appropriation for Part E is \$60,012,000, an increase of \$1,488,000 from the FY 2009 budget estimate of \$58,524,000. The funding will enable DEEOIC to meet its performance plan goals and objectives during FY 2010.

Introduction

The Division of Energy Employees Occupational Illness Compensation's (DEEOIC) core mission is to adjudicate and pay benefits for claims filed under Part B and Part E of the Energy Employees Occupational Illness Compensation Program Act (EEOICPA). Part B provides a lump sum payment of \$150,000 and medical benefits to workers who are seriously ill from exposure to beryllium, silica, or radiation while working for the Department of Energy (DOE), its contractors or subcontractors in the nuclear weapons industry. Part B also provides compensation for some employees' survivors and supplemental lump-sum payments of up to \$50,000 to individuals already found eligible for benefits for illnesses covered under Section 5 of the RECA, and, where applicable, for their survivors. DEEOIC also operates 11 resource centers that provide assistance to claimants in completing benefit applications for both Part B and E of EEOICPA.

Under Part E, the DEEOIC provides compensation to covered DOE contractor employees who are determined under section 3675 to have contracted a covered illness through exposure at a DOE facility. Part E compensation pays benefits to employees based upon degree of impairment and lost wages. Certain survivors of covered DOE contractor employees shall also receive compensation if the covered illness contributed to the employees' death. The amendment also makes it possible for uranium workers eligible under Section 5 of the (RECA) to receive compensation under Part E for illnesses due to toxic substance exposure at a uranium mine or mill covered under that Act. Benefits are paid from the EEOICPA Compensation Fund.

Under Part B, over 97,000 claims have been received from nuclear energy workers and their survivors since the implementation of EEOICPA. As of April 8, 2009, the Division has made more than 68,000 recommended decisions, 65,000 final decisions and payments in over 36,000 Part B claims, totaling more than \$2,918,800,000. Under Part E, EEOICP has received nearly 79,500 claims. DOL has delivered more than \$1,525,355,000 in Part E benefits to more than 14,200 claimants. In addition, more than \$310,740,000 has been paid in medical benefits under both Parts B and E.

FY 2010

The funding request for Part B is \$51,197,000 for FY 2010. This is an increase of \$1,543,000 above the FY 2009 funding level. At this level, DEEOIC will fund 305 FTE and continue to deliver a high level of program performance by processing initial claims and issuing accurate and timely final decisions and delivering timely benefit payments. In addition, DEEOIC will enhance the website with information about program accomplishments, statistics, and graphic comparisons to NIOSH processes. These improvements to the website are intended to enhance transparency for the claimant and general population.

DEEOIC will continue to build a new compensation system designed to unify claims management for Parts B and E. This system will provide more effective case management for all claims staff. By extension, the claimant population will receive a higher level of customer service.

Further, the division is evaluating a streamlined approach for our referrals to District Medical Consultants. This may require that the program obtain a new contract to assist in ensuring that claimants in remote areas receive the highest level of service related to obtaining impairment evaluations and treatment for complicated medical issues related to EEOICP.

DEEOIC will continue to enhance its process for completing timely adjudication of claims returned from HHS/NIOSH with dose reconstructions. DEEOIC will continue to achieve program, operational, and strategic goals. Aggressive outreach efforts to ensure that potential claimants receive current information about the program and application process will continue.

For FY 2010, the Part E estimate is \$60,012,000, which is an increase of \$1,488,000 above the FY 2009 funding level. At this level, DEEOIC will fund 293 FTE. For Part E, the authorizing legislation established indefinite budget authority for the administration of Part E. DEEOIC will continue to maintain a high level of performance by processing initial claims and final decisions in a timely and efficient manner. DEEOIC will also continue its outreach efforts to ensure that potential claimants receive the necessary information about the program and application process.

FY 2009

The funding for Part B of \$49,654,000 for FY 2009 was for DOL operations only. A \$267,000 decrease in funds reflects a projected decrease in non-compensation expenditures in DEEOIC. At this level, DEEOIC funded 305 FTE and delivered exceptional program performance by processing initial claims timely and issuing accurate final decisions. In addition, DEEOIC continued to deliver benefit payments efficiently and expeditiously. DEEOIC maintained its efficiency in processing claims returned from HHS/NIOSH with dose reconstructions, including those for previously adjudicated claims that require re-evaluation based on HHS/NIOSH processing updates. DEEOIC achieved its program, operational, and strategic goals.

In FY 2009 funding for HHS/NIOSH was appropriated directly to HHS. The direct appropriation of HHS/NIOSH funding, enhanced performance management and fiscal accountability for respective activities within both agencies.

For FY 2009, the Part E funding was \$58,524,000, which was \$1,639,000 above the FY 2008 budget authority. The authorizing legislation established indefinite budget authority for the administration of Part E. DEEOIC administered its program activities at full program performance level, and continued to maintain its high level of program efficiency through timely and efficient processing of initial claims and final decisions. DEEOIC outreach efforts continued to ensure that potential claimants receive the necessary information about the program and application process.

FY 2008

Part B funding was \$104,745,000. The appropriation funded both DOL and HHS/NIOSH activities. This amount represents an increase of approximately 2.38 percent from the FY 2007 request. Funding for DEEOIC for FY 2008 was \$49,387,000, which was a decrease of \$584,000 from the FY 2007 request of \$49,971,000. At this level, DEEOIC funded its authorized FTE ceiling of 305 FTE. DEEOIC administered its program activities at full performance level. It maintained its high level of program efficiency through timely and efficient processing of initial claims and final decisions, accurate and timely benefit payments, and processing of dose reconstructions returned from HHS/NIOSH, thus ensuring the ability to achieve program, operational, and strategic goals. In FY 2008, DEEOIC processed initial claims in Part B in an average of 164 days against a target of 226 days. DEEOIC also processed 92.6 percent of its final decisions against a target of 87 percent in both Part B and Part E. DEEOIC received more than 95,100 Part B claims and has made more than 66,000 recommended decisions and 63,250 final decisions in Part B claims since program inception. DEEOIC made payments in over 34,673 Part B claims, totaling more than \$2,810,118,400.

HHS/NIOSH funding was \$55,358,000, an increase of \$3,022,000 from the FY 2007 appropriation of \$52,336,000. HHS/NIOSH completed 9,004 dose reconstructions for FY 2008.

FY 2008 indefinite budget resources for Part E were \$56,885,000 and 293 FTE. DEEOIC administered Part E activities at full performance level. In FY 2008, DEEOIC processed Part E

initial claims in an average of 283.7 days against a target of 290 days. DEEOIC received nearly 77,395 Part E claims since program inception and delivered more than \$1,418,755,000 in Part E benefits to more than 13,177 claimants. In addition, more than \$282,105,000 has been paid in medical benefits under both Parts B and E.

DEEOIC outreach efforts provided potential claimants information about the program and application process. In FY 2008, DOL conducted 24 town hall meetings and 27 traveling resource centers which focused on presenting details about new Special Exposure Cohort classes and explaining how certain Section 5 uranium miners, uranium millers, and ore transporters may qualify for benefits under Parts B and E of the EEOICPA. Of those, 16 town hall meetings and 18 traveling resource centers were targeted to Section 5 uranium workers. Further, staff from each of DOL's 11 Resource Centers attended many community activities across the country in order to disseminate information about the EEOICPA and take new claims.

Workload Summary

At the FY 2010 Request Level of \$51,197,000 for Part B and \$60,012,000 for Part E, the Energy Employees Occupational Illness Compensation Program (EEOICP) will continue to provide quality and timely EEOICP decisions, benefit delivery and case management for the Program's targeted workload. EEOICP will continue its exceptional program administration, with the support of 305 FTE for Part B and 293 FTE for Part E to provide program management, claims adjudication, and customer support services in OWCP; legal support in the Office of the Solicitor; and human resources, financial and other ESA and Departmental-level administrative support. The program expects that NIOSH will continue to add new Special Exposure Cohorts (SEC) and will also continue to change site profiles and methodologies. This will result in a constant re-evaluation of existing claims, as well as an increase in the level of incoming claims.

Reductions due to absorption of higher inflation than was provided in the FY 2009 budget will be taken in non-compensation activities and activities related to program oversight.
